Women gather to thank CM Rekha as Lakshmi Yojana portal goes live August 1

A large number of women gathered at the Delhi Secretariat on Wednesday to greet Chief Minister Rekha Gupta with slogans and applause following the cabinet's approval of the Delhi Lakshmi Yojana the previous day, welcoming the ₹2,500 monthly assistance scheme as a historic step toward women's dignity, self-reliance, and economic empowerment.

The Chief Minister confirmed the portal will go live on August 1 and that efforts will be made to release the first instalment to eligible beneficiaries on Raksha Bandhan.

The gathering at the Secretariat premises broke new ground as the Chief Minister arrived, with women greeting her and interacting with her directly to express their gratitude. They described the

scheme as a decision that would usher in a new era of financial security and self-confidence for lakhs of women in Delhi.

The Chief Minister told the gathering that the honour was not for her personally but for the aspirations and trust of every woman in Delhi.

She said the Delhi Government had taken a significant step toward fulfilling the promise it had made to women and that the trust of

women is the government's greatest strength.

She said the Delhi Lakshmi Yojana is not merely a financial assistance scheme but a broader initiative to enable women to lead self-reliant, empowered, and dignified lives.

The portal will open on August 1, allowing eligible women to submit online applications. Following eligibility verification and approval, the Government

will aim to disburse the first instalment to beneficiaries in the initial phase on the occasion of Raksha Bandhan.

Under the scheme, eligible women between 21 and 60 years of age with a family annual income of up to ₹2.50 lakh will receive ₹2,500 every month. Beneficiaries can choose between two disbursement options: ₹1,500 in an RD or FD with ₹1,000 credited to a CBDC Digital Rupee Wallet, or the entire ₹2,500 deposited in an RD or FD for long-term savings. A budget provision of ₹5,100 crore has been made for the scheme, which is expected to benefit over 17 lakh women.

The scene at the Secretariat on Wednesday, with a crowd of women gathering spontaneously to greet the CM, gave the Government a publicly visible moment to frame the scheme's announcement as a response to genuine popular demand rather than a political calculation.



Delhi Chief Minister Rekha Gupta visited the Maharshi Yalmiki Temple on Mantra Marg on Wednesday on the occasion of Guru Puja, offering prayers. GDA demolishes illegal building, colony in Avantika, Mahrauli

The Ghaziabad Development Authority on Wednesday demolished an unauthorised construction at two separate locations. The GDA razed a building that violated the sanctioned plan at Plot CD-16A in Avantika and demolished an unauthorised colony being developed on approximately 1,600 square yards of land at Village Mahrauli near the Mahagun Group Housing Society. The demolition was opposed from the construction owners managed by the Authority Police Force at both sites.



The GDA registered Case No GDA/ANI/2026/000507 and served a Show Cause Notice and Stop Work Notice on February 26, 2026, followed by a Reminder Notice on March 13, 2026.

Since no satisfactory reply or supporting evidence was submitted by the owners in response, the GDA proceeded with demolition on Wednesday. The unauthorised portion was demolished and rendered unusable, and the construction was also sealed on the same day to prevent any further building activity at the site.

Government simplifies relief for J&K migrants, removes income criterion

Delhi Government has issued a new standard operating procedure (SOP), simplifying monthly relief distribution to Jammu and Kashmir migrants in the city, removing the income criterion, the Chief Minister's Office said on Wednesday.

Chief Minister Rekha Gupta said that the relief distribution process for Jammu and Kashmir migrant families has been made simpler and more transparent.

Now, the applicants for the relief will not require to submit income certificate or property documents. Also, rules on marriage, family bifurcation, arrears and verification process have also

been clarified in the SOP, Delhi CMO said in a statement.

Further, the Government has given a one time special amnesty to the migrant families registered till March 2024, to submit Form-A till

September 15, to declare current family composition, Gupta said.

Every family must submit Form-A for this purpose, she said and clarified that the declarations submitted in April 2026 under the earlier rules will no longer be valid and will be treated as cancelled.

District authorities have been directed to update families for this purpose by September 15 and release ad hoc monthly relief (AMR) based on a maximum of four members per family. Families seeking bifurcation under the prescribed rules will also have to submit Form-B along with Form-A so their applications can be processed accordingly, added the statement.

Manoj Kumar and Sushant Sagar are the part-time members of the newly constituted Delhi Commission for Safai Karmchhari, it said. CM Rekha Gupta expressed confidence that these appointments would enable the Commission to function in a more proactive, effective and people-centric manner.

Metro ridership falls 2.67 lakh during 5-day station closures amid protests

The Delhi Metro Rail Corporation (DMRC) on Wednesday said average weekday passenger journeys fell from 65,93,294 during July 1-19 to 62,25,802 during July 20-24, a decline of around 4.1 per cent.

The corporation said that while there was a slight



decrease in passenger journeys during the period, the decline was not significant in the context of the entire Metro network. "Such trends are often noticed during weekends, holidays and special events," the DMRC said in a statement.

The average weekday ridership during the corresponding periods stood at 68,56,803 in June 2026, 67,40,968 in June 2025 and 66,77,710 in June 2024, according to the data.

During July 20-24, the DMRC had closed entry and

exit at up to 18 stations on the directions of the Delhi Police in view of the Cockerhoo Janta Party (CJP) protests in central Delhi, while interchange facilities remained available at select stations. The restrictions affected commuters travelling to key Government and commercial areas in the city. The restrictions were imposed during protests led by the CJP, which had organised demonstrations at Jantar Mantar and a "Sanskad Chalo" march over alleged examination irregularities.
