Brief Profile (in case of appointment)	Brief Profile of Mr. Manoranjan Panigrahy: Mr. Manoranjan Panigrahy, aged about 61 years, is a Post Graduate from Utkal University (1985) and M. Phil from JNU, Delhi (1988). He joined Indian Revenue Service (IRC) in the year 1989 as Asst. Commissioner of Income Tax. He served the income tax department for more than 35 years. He was Commissioner of Income Tax during 2009-2014, Chief Commissioner of Income Tax during the year 2021 to 2023 and retired as Principal Chief Commissioner of Income Tax (West Bengal, Bihar & Jharkhand and Odisha) for the period from January 2024 to May 2024. In his tenure as a Chief Commissioner of Income Tax, he supervised the work of three Faceless charges of Principal CIT and Nine commissioner of Income Tax (Appeals). Since Income Tax settlement commission was abolished, an Interim Board for Settlement was constituted by the Central Government to dispose of pending cases. There were three members in the Board and he being member-I disposed off as many as 320 cases in a span of 16 months which was highest in India at that time. As Principal CCIT WB, Bihar and Jharkhand, Odisha coinciding with the period of General Election, he had to deploy the manpower to combat the menace of black money used in the election. He had the largest territorial jurisdiction as compared to his colleagues. In addition to the Income tax Department, he was also on deputation during the year 2015-2020 – holding the post of secretary, Odia Language Literature & Culture Department, Government of

	Odisha. As part of “Mukhya Mantri Kalakar Sahayata Yojana”, financial assistance was given to a record number of 35,000 thousand artists during his tenure. For the first time, International Book Fair was organized by Culture Department at Bhubaneswar. Postage stamp commemorating bicentenary of historic Paika rebellion was also released. For the first time a unique program “Ama Loka Kala Ama Sanskruti” was organized by Culture Department to show case our state’s rich tradition of folk dance and music. The Department also organized various functions to mark 150th Anniversary of Father of Nation – Mahatma Gandhi. Seven new galleries were added to the state museum. During his tenure, the Department made its visibility in the public. During his tenure, “Vande Utkal Janani” was adopted as State Song/Anthem and Balijatra was considered as State Festival. It may be mentioned here that because of his good work done in the culture department, he had got 10 out of 10 in his Annual Performance Appraisal Report (APAR) in all five years which were approved/accepted by the then Hon’ble Chief Minister of Odisha.

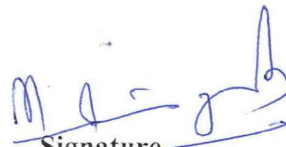
