## उत्तर रेलवे के महाप्रबंधक ने कार्य प्रगति की समीक्षा की

नई दिल्ली, (बीएन) उत्तर रेलवे के महाप्रबंधक, श्री शोभन चौधरी ने आज उत्तर रेलवे के प्रमुख विभागाध्यक्षों एवं मंडल रेल प्रबंधकों के साथ प्रधान कार्यालय, बड़ौदा हाउस, नई दिल्ली में उत्तर रेलवे की कार्य-प्रगति की समीक्षा की। महाप्रबंधक ने बल देकर कहा कि संरक्षण रेलवे की प्राथमिकता है, जिसके लिए ट्रैक, रोलिंग स्टॉक, सिग्नलिंग और इलेक्ट्रिक ओवरहेड तारों को सुचारु बनाए रखने की दिशा में हर संभव प्रयास किए जाने चाहिए। उन्होंने विभागों को सलाह दी कि वे कर्मचारियों के लिए नियमित रूप से प्रशिक्षण और रिशरार कोर्स आयोजित करें ताकि उन्हें प्रेरित किया जा सके और मानवीय त्रुटि को कम करने के लिए सिस्टम के कामकाज

के बारे में जानकारी दी जा सके। यात्रियों की सुविधा बढ़ाने और रेलवे के बुनियादी ढांचे को आधुनिक बनाने के लिए महाप्रबंधक ने अमृत भारत योजना के तहत अमृत स्टेशनों की प्राप्ति और स्टेशनों के पुनर्विकास कार्य का आंकलन करने के लिए व्यापक समीक्षा की। उन्होंने अधिकारियों को स्टेशनों के

- संरक्षण और रेल परिसंपत्तियों के अनुरक्षण पर बल
- मानसून में जलभराव की समस्या से निपटने के लिए निवारक उपायों पर बल
- अमृत स्टेशनों और स्टेशनों के पुनर्विकास कार्यों की समीक्षा

पुनर्विकास कार्य की प्रगति की निगरानी करने और समय पर काम पूरा करने के निर्देश दिए। महाप्रबंधक ने निर्धारित समयवधि के भीतर परियोजनाओं का सफलतापूर्वक निर्माण सुनिश्चित करने के लिए समय पर निष्पादन और गुणवत्ता के महत्व पर जोर दिया। उन्होंने कहा कि मानसून के इस मौसम में संरक्षण पर विशेष ध्यान दिया जाना चाहिए और ट्रैकों के संचालन के दौरान किसी भी तरह की बाधा

को रोकने के लिए सभी प्रयास किए जाने चाहिए। इसके अलावा, उन्होंने सभी मंडलों को ट्रैकों के सुचारु संचालन को सुनिश्चित करने के लिए पटरियों पर जलभराव और गाद जमा होने की समस्या से निपटने के लिए उपाय करने की सलाह दी। महाप्रबंधक ने कहा कि इन चुनौतियों का सक्रियता से समाधान करते हुए उत्तर रेलवे प्रतिकूल मौसम की स्थिति में सेवा विश्वसनीयता बढ़ाने के लिए प्रतिबद्ध है।

## न्यू फरीदाबाद टाउन यार्ड में ट्रैक डीप स्क्रिनिंग का कार्य सफलतापूर्वक किया गया

नई दिल्ली, (बीएन) उत्तर रेलवे के दिल्ली डिवीजन के इंजीनियरिंग विभाग के लिए एक महत्वपूर्ण उपलब्धि है, फरीदाबाद न्यूटाउन यार्ड में अप प्लेटफॉर्म लाइन (387 मीटर) की डीप स्क्रिनिंग सफलतापूर्वक पूरी कर ली गई है। यह कार्य रात्रि ब्लॉक लेकर किया गया था, और यह रेलवे के बुनियादी ढांचे के रखरखाव में सटीकता और दक्षता के उच्च मानकों को दर्शाता है। इस कार्य के दौरान, दो बैलस्ट क्लीनिंग मशीन (बी.सी.एम.), एक यूनिट, एक डी.जी.एस. और एक डब्ल्यू.एस.टी. को शामिल करते



हुए एक समन्वित प्रयास से कार्य के सावधानीपूर्वक निष्पादन को सुनिश्चित किया। प्रक्रिया अप और डाउन दोनों लाइनों के एक साथ ब्लॉक के साथ शुरू हुई, जिससे डीप स्क्रिनिंग और ट्रैक स्लीविंग गतिविधियों के लिए 5.30 घंटे का

समय मिला। बी.सी.एम. ने 240 मीटर ट्रैक को 500-600 तक स्लीव करके एक महत्वपूर्ण भूमिका निभाई, और एक अलग खंड में, बी.सी.एम. और यूनिट को संयोजित उपयोग करके अतिरिक्त 140 मीटर को संभोधित किया गया। इसके बाद, यूनिट और वस्तु का सक्रिय उपयोग करके ट्रैक को उसके अंतिम संरक्षण में वापस समायोजित कर लगाया गया ताकि भविष्य के संचालन के लिए सटीकता और संरक्षा सुनिश्चित की जा सके। इस प्रक्रिया में बीसीएम, यूनिट और द्वारा बाद के

समायोजन और अंतिम संरक्षण किया गया। यह कार्यप्रणाली गारंटी देता है कि ट्रैक संरक्षा और परिचालन मानकों को और बेहतर तरीके से पूरा करता है। इस परियोजना का सफल निष्पादन दिल्ली डिवीजन के समर्पण और विशेषज्ञता और रेलवे के बुनियादी ढांचे की गुणवत्ता को बनाए रखने और बढ़ाने के लिए उनकी प्रतिबद्धता को दर्शाता है। यह उपलब्धि सभी यात्रियों के लिए कुशल और सुरक्षित और आरामदायक रेल यात्रा सुनिश्चित करने के लिए चल रहे प्रयासों का प्रमाण है।

## अदालत ने केजरीवाल, सिसोदिया, के. कविता की न्यायिक हिरासत बढ़ाई

नई दिल्ली, (विस्) राष्ट्रीय राजधानी में एक अदालत ने कथित आबकारी नीति घोटाले से संबंधित धनशोधन के मामले में दिल्ली के मुख्यमंत्री अरविंद केजरीवाल और पूर्व उपमुख्यमंत्री मनीष सिसोदिया की न्यायिक हिरासत बुधवार को 13 अगस्त तक बढ़ा दी। विशेष न्यायाधीश कावेरी बावेजा ने मामले में भारत राष्ट्र समिति (बीआरएस) की नेता के. कविता की हिरासत भी 13 अगस्त तक के लिए बढ़ा दी। न्यायाधीश ने इससे संबंधित भ्रष्टाचार के मामले में सिसोदिया और कविता की न्यायिक हिरासत नौ अगस्त तक बढ़ा दी। इस मामले की जांच

केंद्रीय अन्वेषण ब्यूरो (सीबीआई) द्वारा की जा रही है। आरोपियों की न्यायिक हिरासत की अवधि समाप्त होने पर अदालत में पेश किये जाने के बाद न्यायाधीश ने यह आदेश पारित किया। अदालत ने 25 जुलाई को धनशोधन मामले में केजरीवाल की न्यायिक हिरासत 31 जुलाई तक बढ़ा दी थी, जबकि भ्रष्टाचार मामले में उनकी हिरासत आठ अगस्त तक के लिए बढ़ाई गई थी। उच्चतम न्यायालय ने प्रवर्तन निदेशालय (ईडी) द्वारा की जा रही जांच से संबंधित मामले में केजरीवाल को अंतरिम जमानत दे

दी थी। हालांकि, वह अब भी तिहाड़ जेल में बंद है क्योंकि उन्होंने मामले में जमानत बाण्ड नहीं भरा है। दिल्ली के मुख्यमंत्री सीबीआई की जांच से जुड़े मामले में न्यायिक हिरासत में हैं।

## कीर्तिनगर में एक भवन में लगी आग, 10 लोगों को बचाया

नई दिल्ली, (बीएन) कीर्तिनगर स्थित एक आवासीय इमारत में बुधवार को आग लगने के बाद 10 लोगों को वहां से सुरक्षित बाहर निकाला गया। दिल्ली अग्निशमन सेवा (डीएफएस) के अधिकारियों ने यह जानकारी दी। डीएफएस के एक वरिष्ठ अधिकारी ने बताया,

सुबह आठ बजे कर 40 मिनट पर एक घर में आग लगने के संबंध में फोन से सूचना मिली।
