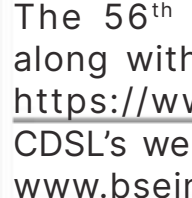

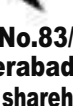

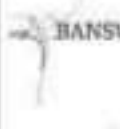

साइबर ठगी ● निकासी के नाम पर ठगों की मांग बढ़ती गई और रकम

नईदुनिया प्रतिनिधि, भोपाल : शेयर बाजार में निवेश कर रातोंरात अरबपति बनने का लालच भोपाल के 67 वर्षीय बुजुर्ग को भारी पड़ गया। साइबर ठगों ने खुद को निवेश कंपनी का ब्रोकर बताकर उन्हें फर्जी ट्रेडिंग एप से जोड़ दिया और देखते ही देखते उनकी 3.91 करोड़ रुपये की जीवनभर की कमाई हड़प ली। ठगों का सबसे बड़ा हथियार वह फर्जी एप था, जिस पर हर निवेश के साथ रकम बढ़ती दिखाई देती थी। करीब एक महिने के भीतर एप पर बुजुर्ग की कुल संपत्ति 62.31 अरब रुपये दिखने लगी।

इस चमकती हुई रकम के लालच में उन्होंने अपनी बचत के साथ अन्य स्रोतों से जुटाए करोड़ों रुपये भी निवेश कर दिए। जब रकम निकालने की बारी आई तो ठगों ने प्रोसेसिंग फीस, अनलाक चार्ज और अन्य शुल्क के नाम पर और रकम मांगनी शुरू कर दी। आखिर में न 62 अरब

महाकाल मंदिर परिसर में सुरक्षाकर्मी पर चाकू से हमला

नईदुनिया प्रतिनिधि, उज्जैन : श्री महाकालेश्वर मंदिर में शुक्रवार को सुरक्षा व्यवस्था पर गंभीर सवाल खड़े करने वाली घटना सामने आई। मंदिर परिसर में तैनात सुरक्षाकर्मी पर बदमाशों ने चाकू से हमला कर दिया। गंभीर रूप से घायल सुरक्षाकर्मी को अस्पताल में भर्ती कराया गया। **घटना ऐसे समय हुई है, जब महज तीन दिन बाद श्रावण मास की शुरुआत होने जा रही है और मंदिर में प्रतिदिन लाखों श्रद्धालुओं के पहुंचने की संभावना है। ऐसे में मंदिर के सुरक्षाकर्मी पर हुए हमले ने सुरक्षा व्यवस्था को लेकर चिंता बढ़ा दी है।**

पुलिस के अनुसार, हमले में घायल सुरक्षाकर्मी आकाश राठौर महाकाल मंदिर की क्यूआरटी (क्विक

रिस्पांस टीम) का सदस्य है। शुक्रवार दोपहर वह परिसर में धनुष द्वार के समीप था, तभी उसे तीन लोगों ने घेर लिया। इनमें से एक युवक ने चाकू से वार किए। अन्य सुरक्षाकर्मी साथी को बचाने पहुंचे तो आरोपित और उसके दो साथियों ने उन्हें भी चाकू मारने की धमकी दी। इस पर वे ठहर गए। इसके बाद तीनों हमलावर फरार हो गए। आरोप है कि फूल-प्रसाद बेचने वाले युवक अशुभल ने चाकू मारे। वह भूरा की फूल-प्रसाद की दुकान पर काम करता है। पुलिस हमलावरों की तलाश में जुटी है और आसपास लगे सीसीटीवी कैमरों के फुटेज खंगाले जा रहे हैं। पुलिस के अनुसार, प्रारंभिक जांच में हमला आपसी विवाद से जुड़ा होने की जानकारी मिल रही है।
