Ashwini Container Movers FY2026 Revenue grows by 36%

FY2026 PAT increases by 22%

Navi Mumbai, July 06, 2026: Ashwini Container Movers Limited (ACML), a leading Second-Party Logistics (2PL) service provider specialising in export / import cargo transportation, has announced its results for year ended on March 31, 2026.

FY2026 financial highlights

Total Revenue for FY2026 was at ₹ 130.3 crores, up 36% over ₹ 96.06 crore revenue of FY2025. EBITDA for FY2026 was at ₹ 33.24 crores, up 33% over FY2025 EBITDA of ₹ 24.92. Profit after Tax (PAT) for FY2026 was ₹ 14.06 crores compared to PAT of ₹ 11.52 crore achieved during the FY2025, an increase of 22% over the previous year. Diluted EPS for FY26 was ₹ 12.32 compared to diluted EPS of ₹ 11.52 reported in FY25.

Key business highlights for FY2026

During Q4 FY2026, ACML, which operated over 300 trailers for its customers' cargo movements to and from ports, started deploying trailers for cargo movement within the ports with a multi-year (4 years, extendable by another 2 years) contract worth ₹ 60 crore (over 4 years) from one of the leading terminal operators at JNPT port.

Commenting on FY2026 performance, **Mr. Sainath Bhaskar Pawar, CEO & Director, ACML** said, "Financial year 2026 was a landmark year in Ashwini Container Movers' journey so far. In December 2025, the company made a successful stock market debut by getting listed on NSE Emerge (SME Segment) platform. During the year, we expanded our fleet size of fully owned vehicles which now stands at a robust 401 trucks and trailers, one of the largest in 2PL segment. Our superior FY 2026 financial performance is a testimony of our proven business model, and complete reliability that we offer to our customers."

War-led Business Disruption

The Shipping Disruptions due to the geopolitical tensions in West Asia, and the subsequent congestions at the port during the first quarter of FY2027 had a material operational impact on Ashwini Container Movers Limited (ACML).

ACML's business is largely dependent on container transportation linked with JNPT, Maharashtra and Gujarat ports. JNPT faced heavy pendency and evacuation delays due to shortage of trailers/drivers (due to drivers returning to their native places due to war related disruptions), and, at the same time, increased import volumes. Containers are reportedly held up for nearly as long as two weeks, and normalisation is expected only by mid-June.

Further, JNPA had officially clarified that although port terminals are operational, delays are occurring mainly because of shortage of trailers and drivers for container evacuation. The port authority also stated that geopolitical disturbances in the Middle East have increased transshipment cargo and container occupancy levels.
