Ashwini Container Movers enters new segment with ₹60 crore, 4-year contract win - Expands service portfolio with entry into high-volume intra-port logistics

Navi Mumbai, January 14, 2026:

Ashwini Container Movers Ltd. (ACML), a leading Second-Party Logistics (2PL) service provider specialising in export / import cargo transportation, has announced that the company has expanded its business offering.

ACML, which currently operates over **300 trailers** for its customers' cargo movements to and from ports, will now deploy trailers for **cargo movement within the ports**. The company has recently won a **multi-year (4 years, extendable by another 2 years) contract worth ₹ 60 crore** (over 4 years) from one of the leading terminal operators at JNPT port.

Operational Deployment

Commencing February 1, 2026, ACML will deploy a fleet of 30 powered vehicles at Jawaharlal Nehru Port Authority (JNPA), Mumbai, for comprehensive high-volume logistics operations including ITV movements, yard management, rail/ICD transfers, and inter-terminal shuttles on a 24/7 basis. Each vehicle is projected to handle **1,700–2,000 movements per month**, delivering an aggregate fleet capacity of 51,000–60,000 movements at full utilization, with all movements covering distances under 20 km.

Strong Track Record at Key Ports

ACML currently moves customers cargo at JNPT port in Maharashtra and Hazira port in Gujarat, with exports cargo movement forming significant part of its business. ACML handled 23,969 containers at JNPT during FY25, catering to Pharma, FMCG, Chemicals, Engineering, and Auto sectors. The company has long standing relationships with reputed corporate exporters, which provides long term revenue visibility.

Commenting on the order win, **Mr. Sainath Bhaskar Pawar, CEO & Director, ACML** said, "This prestigious order win marks our entry into a new line of business of operating fleets within the port terminal. With JNPA handling over 2.5 crore annual internal container movements, ACML's launch targets an initial ~6 lacs p.a movement, positioning the company to capture substantial growth in this high-potential segment. The team at ACML is very excited to win this order, and we look forward to scale up this line of business, contributing significantly to ACML's total revenue in future."
