Pursuant to Regulation 30 of the Listing Regulations read with SEBI Circular no. SEBI/HO/CFD/CFD-PoD-1/P/CIR/2023/123 dated 13th July, 2023 (“SEBI Circular”), we wish to inform that the Company is setting up additional capacity of its tufting line in its factory at Pollachi, Tamil Nadu for which a capex outlay of Rs.4.51 Cr (approx.) is envisaged.
