'OVER REGULATION MUST BE AVOIDED' Digital monopolies a risk to free market: FM

New Delhi, May 20

DELAYS IN REGULATORY clearances could lead to uncertainty and disrupt commercial timelines, finance minister Nirmala Sitharaman warned on Tuesday. She, however, added that emergence of gate-keeper platforms and cross-border digital monopolies are posing challenges for the free and fair markets. Dealing with such monopolies requires global cooperation and agile regulations, she said.

Speaking at the 16th Annual Day of the Competition Commission of India (CCI) here, the minister also underlined the need to facilitate swift and seamless approvals for combinations that pose little harm to competition.

The CCI is also a regulator of mergers and acquisitions, as it wants to ensure that amalgamation of businesses don't result in excessive market power concentration in the relevant markets. Such eventualities are considered to be potentially inimical to competition and free market. In recent years, the regulator is seen to have given fast-paced approvals for many M&As.

The minister drew attention to the fact that the world is facing multiple challenges with concerns over the tempo

of exports amid tepid world trade, as well as over environment, energy and emissions. Given the increased resort to domestic growth levers in this context, it is vital to strike the right balance of regulation and freedom, she emphasised.

"In addition to the traditional challenges, recent years have also seen emergence of new challenges. Artificial intelligence technologies raise novel questions about market power, transparency, data access, algorithmic biases, and also scope of competitive harm," she said.

The finance minister said that as India is negotiating free trade agreements (FTAs) with different countries, the nimbleness and the readiness of a regulator is keenly watched by investors. "Whether it is litigation, time consumed in litigation, or when the regulators are less transparent, negotiations can get complicated. It is therefore imperative that the

No increase in food inflation likely: food secy

EVEN AS FOOD inflation is at a multi-year-low level, the government does not foresee any spike in prices of agricultural commodities over the next few months, food secretary Sanjeev Chopra said on Tuesday.

"With bumper production of wheat and rice, from the point of food inflation, I do not see any concern. We are expecting a much better crop next year," Chopra told FE. This augurs well for the monetary easing cycle that is currently under way. Though subdued prices could adversely affect farmers, robust procurement at minimum support prices could come to their aid.

Retail food inflation



dropped to a 42nd month low to 1.78% in April 2025 on year, as prices of vegetables, pulses, meat, fish and spices declined with the arrival of crop.

However, the rise in global prices pushed up prices of mustard oil and refined oil to 19.6% and 23.75% respectively last month as the country imports about 58% of its edible oil consumption.

Quality control order on electrical items postponed

THE GOVERNMENT HAS postponed the implementation of the Quality Control Order (QCO) on electrical appliances for a year on industry demand.

The demand was made at the stakeholder meet organised by the Department for Promotion of Industry and Internal Trade (DPIIT) with different associations of manufacturers of electrical appliances on Thursday.

The Safety of Household, Commercial and Similar Electrical Appliances (Quality Control) Order, 2025 will not be applicable from 19th March 2026, according to a statement by the Department for Promotion of Industry and Internal Trade (DPIIT). The QCO applies to all electrical appliances intended for household, commercial, or similar applications with rated voltage not exceed-

ing 250V for single-phase appliances and 480V for others, including DC-supplied and battery-operated appliances. The QCO also gives additional time of six months to Micro and Small Enterprises (MSEs); and a 3-month extension for small enterprises. Exemption for imports by domestic maker for producing export-oriented products has also been provided.
