With reference to the captioned subject, we wish to inform that the Board of Directors of KIMS Health Care Management Limited ("KHML"), a material subsidiary of the Company, at its meeting held today, i.e., 31 August 2026, approved the construction of KIMSHEALTH New Block and optimization of the existing hospital facilities, which would result in an increase in operational expansion of capacity at the KIMSHEALTH Hospital, Trivandrum, Kerala.
