Declared a dividend of Rs. 2.20 per equity share (110% of face value)

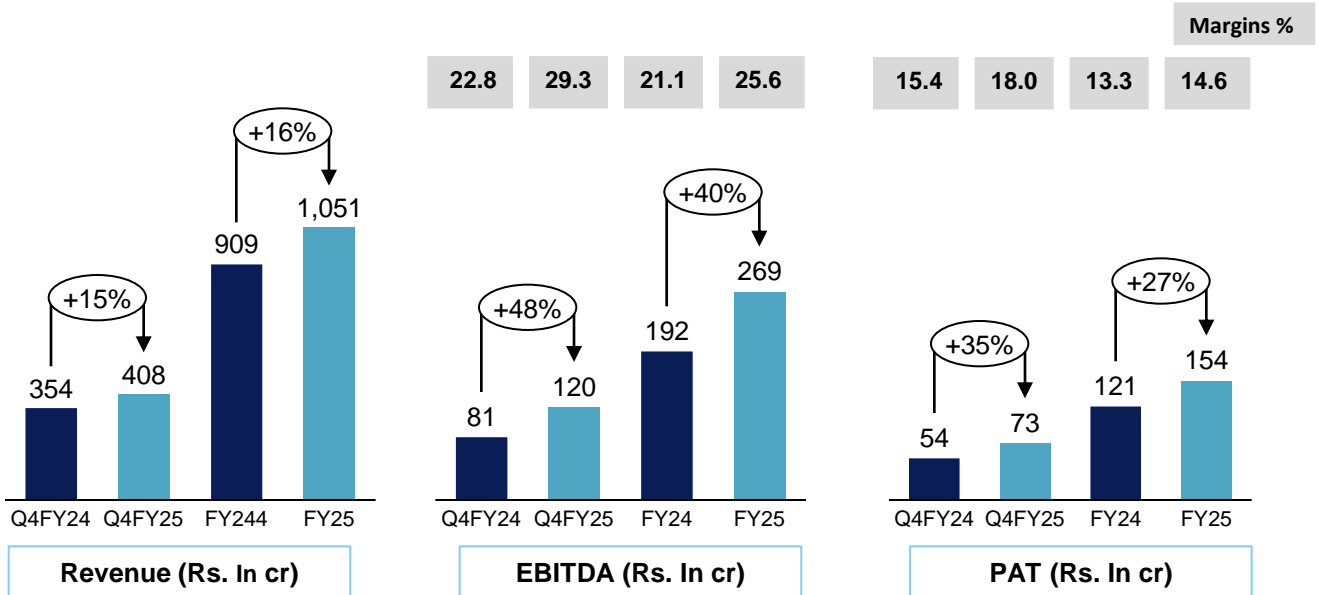
**Thursday, 22<sup>nd</sup> May 2025, Hyderabad** – Astra Microwave Products Limited, engaged in the business of designing, developing and manufacturing of Defence, Aerospace & Space Electronics systems, sub-systems and components announced its audited Financial Results for the quarter and full year ended 31<sup>st</sup> March 2025.

#### Consolidated Q4 FY25 Result Highlights (To be updated)

- Revenue stood at Rs. 408 crores for Q4FY25 as against Rs. 354 crores for Q4FY24
- Gross margins expanded to 46.1% for Q4FY25 as against 38.1% in Q4FY24
- EBIDTA margins improved to 29.3% for Q4FY25 as against 22.8% in Q4FY24
- PAT was at Rs. 73 crores for Q4FY25 as against Rs. 54 crores in Q4FY24 (18.0% PAT Margin)

#### Consolidated FY25 Result Highlights (To be updated)

- Revenue stood at Rs. 1051 crores for FY25 as against Rs. 909 crores for FY24
- Gross margins improved to 45.1% for FY25 as against 39.9% in FY24
- EBIDTA margins was 25.6% for FY25 as against 21.1% in FY24

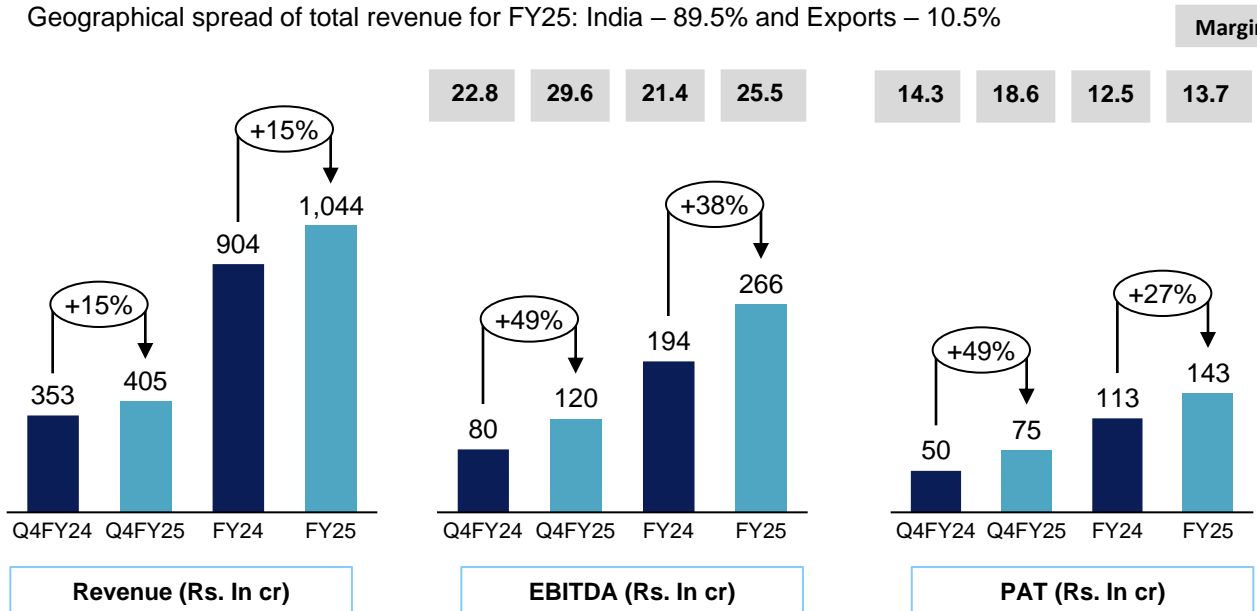

- Gross margins expanded to 45.5% for Q4FY25 as against 37.3% in Q4 FY24
- EBIDTA margins stood at 29.6% as against 22.8% in Q4 FY24
- PAT was at Rs. 75 crores for Q4FY25 as against Rs. 50 crores in Q4FY24 (18.6% PAT Margin)
- Geographical spread of total revenue for the quarter: India – 92.8% and Exports – 7.2%

### Standalone FY25 Result Highlights

- Revenue stood at Rs. 1,044 crores for FY25 as against Rs. 904 crores for FY24
- Gross margins surged up to 43.9% for FY25 as against 39.1% in FY24.
- EBIDTA margins was 25.5% for FY25 as against 21.4% in FY24
- PAT was at Rs. 143 crores for FY25 as against Rs. 113 crores in FY24 (13.7% PAT Margin)
- Geographical spread of total revenue for FY25: India – 89.5% and Exports – 10.5%

Also, I would like to update you that the Board has approved dividend distribution of Rs. 2.20 per share (110 % of the face value).*
