However, the Company has not received the copy of order or any other communication from any Authority in this regard. Details of the violation(s)/ contravention(s) committed or alleged to be committed	The Labour Commissioner, Gujarat state, Gandhinagar Vide its Order No. K.H.A.H.M.C./41248/5/2/IDR/AJ/170/2021 dtd.18/11/2021, referred the dispute to the Industrial Tribunal, Vadodara for determining the industrial dispute and complaint raised by Shramik Kamdar Kalyan Sangh and Bharuch Jilla Mazdoor Sangh (“Union”) against the Company regarding raise in pay, other allowances and benefits of the workmen working in the Company’s plant located at Jhagadia, District Bharuch, Gujarat.
