This Report is issued in accordance with the terms of the service scope letter with Axis Trustee Services limited (hereinafter referred to as "Debenture Trustee") for the issuance of the Security Cover Certificate of **M/s. Shree Cement Ltd** (hereinafter referred to as the "Company") vide mail dated 6th May' 2025.
2. We **JAIN GOPAL & CO**, Chartered Accountants, have been engaged by the Debenture Trustee by mail of dated 6th May' 2025 to examine the documents and details provided to us by the Company for issuing Security Cover certificate as per the requirements of SEBI guidelines under sub regulation 56(1)(d) of SEBI LODR Regulations 2015 read with SEBI circular No. SEBI/HO/DDHS-PoD3/P/CIR/2024/46 dated 16th May' 2024. The said certificate is being issued as on **31st Mar'2025** as mandated by the debenture trustee for issuance and listing of Non-Convertible Debentures. This Report is required by the Debenture trustee to ensure compliance with the SEBI Regulations.
3. The Company management is responsible for ensuring that the company complies with the LODR regulations and DT Regulations.
4. We have conducted our examination of the Statement in accordance with the Guidance Note on Reports or Certificates for Special Purposes issued by ICAI. The Guidance Note requires that we comply with the ethical requirements of the Code of Ethics issued by the ICAI.
5. We have complied with the relevant applicable requirements of the Standard on Quality Control (SQC) 1, Quality Control for Firms that Perform Audits and Reviews of Historical Financial Information, and Other Assurance and Related Service Engagements.
6. Our scope of work did not involve us performing audit for the purposes of expressing an opinion on the fairness or accuracy of any of the financial information or the financial results of the Company taken as a whole. We have not performed an audit, the objective of which would be expression of an opinion on the financial results, specified elements, accounts or items thereof, for the purpose of this report. Accordingly, we do not express such opinion.
7. A reasonable assurance engagement includes performing procedures to obtain sufficient appropriate evidence on the applicable criteria, mentioned in paragraph 5 above. The procedures selected depend on the auditor's judgment, including the assessment of the risks associated with the applicable criteria. Accordingly we have performed the following procedures in relation to the Statement :
 - a) Traced the Book value of the assets and liabilities as on **31st Mar'2025** from the Security cover certificate issued by the Co.'s Statutory Auditor and Some of the data from the financial results for the year ending **31st Mar'2025**.
 - b) Verified that the formula for the Security Cover is as defined by Securities Exchange Board of India vide Sebi circular No- SEBI/HO/DDHS-PoD3/P/CIR/2024/46 dated 16th May' 2024.
 - c) Computed and compiled the security Cover ratio in accordance with Debenture Trust Deed.

Based on the Security cover Certificate issued by the Co's Statutory Auditor for the period ended **31st Mar'2025** and the latest valuation reports as provided, we hereby certify that the company is maintaining **0.44 times** of Security cover on book value and **6.51 times** on market value and is determined in accordance with requirements of the information memorandum, Companies Act 2013 and SEBI LODR, as applicable.

Further as the liability of ECB, TL & other loan during this Mar 25 Qtr had come down from 173.46 Crs in Dec 24 Qtr to 89.83 Crs as on 31.03.25 and because of this, the security cover ratio in BV increased from 0.42 to 0.44 in Mar 25 Qtr. In line with that, the security cover ratio at MV was also increased from 6.00 to 6.51 times in Mar 25 Qtr. There is no deviation in the methodology for calculating security cover ratio as compared with the previous quarter.
