We **JAIN GOPAL & CO**, Chartered Accountants, have been engaged by the Debenture Trustee by mail of dated 30th July' 2025 to examine the documents and details provided to us by the Company for issuing Security Cover certificate as per the requirements of SEBI guidelines under sub regulation 56(1)(d) of SEBI LODR Regulations 2015 read with SEBI circular No. SEBI/HO/DDHS-PoD-1/P/CIR/2025/117 dated 13th August '2025.

The said certificate is being issued as on **30th June'2026** as mandated by the debenture trustee for issuance and listing of Non-Convertible Debentures. This Report is required by the Debenture trustee to ensure compliance with the SEBI Regulations.

3. The Company management is responsible for ensuring that the company complies with the LODR regulations and DT Regulations.
4. We have conducted our examination of the Statement in accordance with the Guidance Note on Reports or Certificates for Special Purposes issued by ICAI. The Guidance Note requires that we comply with the ethical requirements of the Code of Ethics issued by the ICAI.
5. We have complied with the relevant applicable requirements of the Standard on Quality Control (SQC) 1, Quality Control for Firms that Perform Audits and Reviews of Historical Financial Information, and Other Assurance and Related Service Engagements.
6. Our scope of work did not involve us performing audit for the purposes of expressing an opinion on the fairness or accuracy of any of the financial information or the financial results of the Company taken as a whole. We have not performed an audit, the objective of which would be expression of an opinion on the financial results, specified elements, accounts or items thereof, for the purpose of this report. Accordingly, we do not express such opinion.
7. A reasonable assurance engagement includes performing procedures to obtain sufficient appropriate evidence on the applicable criteria, mentioned in paragraph 5 above. The procedures selected depend on the auditor's judgment, including the assessment of the risks associated with the applicable criteria. Accordingly we have performed the following procedures in relation to the Statement :
 - a) Traced the Book value of the assets and liabilities as on **30th June'2026** from the Security cover certificate issued by the Co.'s Statutory Auditor the Qtr ending **30th June'2026**
 - b) Verified that the formula for the Security Cover is as defined by Securities Exchange Board of India vide Sebi circular No- SEBI/HO/DDHS-PoD-1/P/CIR/2025/117 dated 13th August '2025..
 - c) Computed and compiled the security Cover ratio in accordance with Debenture Trust Deed.

Based on the Security cover Certificate issued by the Co's Statutory Auditor for the period ended **30th June'2026** and the latest valuation reports as provided, we hereby certify that the company is maintaining **0.37 times** of Security cover on book value and **7.18** times on market value and is determined in accordance with requirements of the information memorandum, Companies Act 2013 and SEBI LODR, as applicable.

Further we state that the security cover ratio on market value is decreased marginally from 7.31 times to 7.18 times in this June'2026 in comparison to the previous March'2026 due to increased liability as on 30.06.26. There is no deviation in the methodology for calculating security cover ratio as compared with the previous quarter
