3. With respect to the aforementioned query, we submit that Accounting Standard (hereinafter referred to as "AS") 17 on Segment Reporting, issued by the Institute of

Chartered Accountants of India (hereinafter referred to as "ICAI"), defines a "business segment" under paragraph 5.1 as follows:

"5.1 A business segment is a distinguishable component of an enterprise that is engaged in providing an individual product or service or a group of related products or services and that is subject to risks and returns that are different from those of other business segments."

- 4. In terms of the above definition, a "business segment" refers to a distinct unit within an enterprise that offers specific products or services and is exposed to risks and returns that are materially different from those of other segments within the same enterprise.
- 5. It is submitted that the Company is primarily engaged in the business of manufacturing, exporting, and supplying Discharge and Collecting Electrodes, as well as internal parts and spares of Electrostatic Precipitators, which are predominantly composed of iron and steel.
