Dear Sir/Madam,

Pursuant to Regulation 30 read with Schedule III, Part A Para A (7) of SEBI Listing Regulations, we wish to inform you that Mr. Srirang Athalye, Non-Executive Director of the Company, has resigned from the Board of Directors of the Company with effect from the close of business hours on July 31, 2025. Consequently, he shall also cease to be a member of the Committees of the Company, in which he was a member.

Mr. Athalye has conveyed that, with the appointment of Mr. Ashish Deora as a Non-Executive Director on the Board, he believes this is an appropriate juncture for him to step down from his current role.

Following the receipt of his resignation, the matter was reviewed internally. The Board acknowledged that Mr. Athalye's extensive industry experience and valuable strategic contributions to the Company and expressed its unwillingness to accept his resignation at this stage.

However, considering Mr. Athalye's continued interest in supporting the Group's strategic initiatives, it was mutually agreed that he would step down from his role as Director and continue to remain associated with the Group in a different capacity.

Accordingly, Mr. Srirang Athalye has been appointed as a Key Managerial Personnel of Bonds Brain Technologies Private Limited, a wholly owned subsidiary of the Company. This subsidiary has recently received registration from SEBI as a 'Small and Medium Real Estate Investment Trust (SM-REIT)' under the name Amsa Small and Medium Real Estate Investment Trust.



Post multiple discussions, the resignation was duly accepted by the Company on August 05, 2025. Hence, there was a delay in filing the disclosure.

In accordance with the requirements of the SEBI Listing Regulations and SEBI Circular No. SEBI/HO/CFD/PoD2/CIR/P/0155 dated November 11, 2024, the requisite details of the resignation are enclosed as **Annexure-A** and a copy of Mr. Srirang Athalye's resignation letter dated July 31, 2025 is enclosed as Annexure-B.
