‘पीएफआय’चे देशात ५० हजारांहून अधिक सदस्य!

२०१७ मध्येच १९ पाणी दस्तावेज तयार

लोकसत्ता विशेष प्रतिनिधी

मुंबई : ‘इस्लामिक स्टेट’ (आयएस) या अतिरेकी संघटनेशी ‘फॉय्युलर फ्रंट ऑफ इंडिया’च्या सदस्यांचा थेट संबंध असल्याची माहिती राष्ट्रीय तपास यंत्रणेने २०१७ मध्ये केंद्रीय गृह मंत्रालयाला सादर केलेल्या १९ पाणी डॉसिअरमध्ये (दस्तावेज) दिली होती, असे कळते. त्या वेळी या संघटनेचे अस्तित्व दक्षिणेतील केरळ व तमिळनाडू या दोन राज्यांपुरतेच होते. मात्र त्यानंतर त्यांनी १८ पेक्षा अधिक राज्यांमध्ये हातपाय पसरवत अधिकृतपणे ५० हजार सदस्यांची नोंदणी केल्याची बाब आतापर्यंतच्या तपासात उघड झाली आहे.

२०१६ व २०१७ मध्ये केरळ पोलीस तसेच राष्ट्रीय तपास यंत्रणेला या दहशतवादी कृत्याची माहिती मिळाली होती. या संघटनेला आखाती देशांतून अर्थपुरवठा होत असल्याची खात्रीलायक माहिती २०१८ मध्ये सक्तवसुली संचालनालयाच्या तपासात उघड झाली होती. तरीही या संघटनेवर बंदी घालण्यासाठी केंद्राने आणखी ठोस पुरावे गोळा करण्यास सांगितले होते. ती खात्री पटल्यानंतरच एकाच वेळी कारवाई करून या संघटनेवर बंदीही घालण्यात आली. या बंदी आदेशाला न्यायालयात आव्हान मिळाले तरी बंदी टिकून राहिली पाहिजे हा त्यामागील हेतू होता, याकडे या तपासाशी संबंधित वरिष्ठ सूत्रांनी लक्ष वेधले. २०१८ मध्ये या संघटनेने झारखंड राज्यात घातपाती कारवाया सुरू केल्या तेव्हा तेथील राज्य सरकारने या संघटनेवर बंदी घातली. मात्र बंदी घालताना आवश्यक त्या प्रक्रियेचे पालन केलेले नाही, असे स्पष्ट करीत उच्च



न्यायालयाने बंदी उठविली होती. त्यानंतर २०१९ मध्ये झारखंडने पुन्हा या संघटनेवर बंदी घातली. इस्लामविरोधी घटनांना कडाडून विरोध करण्यामध्ये ही संघटना आघाडीवर असल्याचा अहवाल मिळाल्यानंतर उत्तर प्रदेश सरकारने या संघटनेवर बंदी घालण्याचा प्रस्ताव २०२० मध्ये केंद्र सरकारला पाठविला होता. मात्र बंदी घातल्यानंतर ती न्यायालयाकडून उठविली जाऊ नये, असा केंद्र सरकारचा प्रयत्न होता. त्यामुळे ठोस पुरावे हाती आल्यानंतरच बंदीची कारवाई करण्याचे ठरविण्यात आल्याचेही या सूत्रांनी सांगितले. २०१३ पासूनच ही संघटना सक्रिय झाली होती. केरळातील नारथ येथे प्रशिक्षण केंद्र उभारण्यात या संघटनेचा हात होता. केरळात विशिष्ट धर्माच्या नेत्यांच्या हत्या प्रकरणात या संघटनेच्या सदस्यांचा हात असल्याचे स्पष्ट झाल्यापासून या संघटनेवर नजर होती. स्टुडन्ट्स इस्लामिक मुव्हमेंट ऑफ इंडिया म्हणजे सिमीची ही संघटना सुधारित आवृत्ती होती. आपण पकडले जाऊ नये यासाठी सिमीप्रमाणे सरसकट सदस्य नोंदणी टाळण्यात आली होती. अनेक बुद्धिजीवी या संघटनेत सक्रिय होते, असेही या सूत्रांनी सांगितले.

आतापर्यंत दोन वेळा आरोपपत्र दाखल करण्यात आले आहे. त्रिपाठी यांनी अंगडिया व्यावसायिकांवर कोणतीही कारवाई न करण्यासाठी १० लाख रुपये प्रति महिना मागितल्याची तक्रार अंगडिया व्यावसायिकांच्या संघटनेने केली होती. त्रिपाठी यांच्या सूचनेवरून लोकमान्य टिळक (एल.टी.) मार्ग पोलीस ठाण्यात अंगडिया व्यावसायिकांना डांबून ठेवून त्यांच्याकडून खंडणी उकळण्यात आल्याचा आरोप आहे. या प्रकरणी १९ लाख रुपये अंगडियांकडून घेण्यात आले होते. त्यातील दीड लाख रुपये त्रिपाठी यांना हवालामार्फत पाठवल्याचा आरोप आहे. ती रक्कम स्वीकारल्याप्रकरणी त्रिपाठी यांच्या नोकरालाही अटक झाली होती.

या गुन्ह्यामध्ये अतिरिक्त पोलीस आयुक्त (दक्षिण प्रादेशिक परिमंडळ) दिलीप सावंत स्वतः तक्रारदार आहेत. त्यांच्या तक्रारीवरून हा गुन्हा दाखल करण्यात आला होता. या प्रकरणी उपायुक्त त्रिपाठी यांनी पैसे मागितल्याबाबत अंगडिया व्यावसायिकांनी तक्रार केली होती. त्यामुळे अतिरिक्त पोलीस आयुक्त दिलीप सावंत यांच्याकडे चौकशी देण्यात आली. गुन्हा दाखल झाल्यानंतर या प्रकरणाचा तपास गुन्हे शाखेच्या गुन्हे गुप्तवार्ता पथकाला (सीआययू) वर्ग करण्यात आला होता.
