Antony Waste Handling Cell Limited: Q2FY22 Results

- Total Operating Revenue of Rs. 143 crores; QoQ growth of 9%, YoY growth of 35%
- EBITDA of Rs. 42 crores, QoQ growth of 2%, YoY growth of 30%
- EBITDA Margin of 26.8%
- PAT of Rs. 24 crores, QoQ growth of 6%, YoY growth of 33%

Mumbai, November 12, 2021: Antony Waste Handling Cell Ltd., leading player in the Indian MSW service industry, today announced its financial results for the quarter and half year ended September 30, 2021.

Key Highlights

- Revenue from operations for the quarter ended September 30, 2021 improved resultant to increased tonnage because of easing of lockdown and commencement of commercial activities in regions where AWHCL (and its subsidiaries) operate.
- Q2 FY22 has reported a growth of around 12% as compared to Q1 FY22 and a growth of around 20% as compared to Q2FY21 in total tonnage handled by the Collection & Transportation business (excluding those projects with fixed shifts/trips)
- A growth of 4% on sequentially basis in total waste processed by the Company during Q2 FY22 and a growth of around 12% on YOY basis.
- Total compost sales for Q2FY22 stood at 2,908 tons compared to 4,850 tons in Q1FY22 and 3,327 tons in Q2FY21.
- **MSW C&T sales are up by 11% to Rs. 105 crores in Q2FY22** as compared to Rs. 95 crores in Q1FY22
- **MSW Processing sales are up by 4% at Rs. 38 crores in Q2FY22** as compared to Rs. 36 crores in Q1FY22

Commenting on the results, Jose Jacob, Chairman & Managing Director, Antony Waste Handling Cell Ltd. said,

“We continue to see upward trajectory in our financial and operational performance during Q2FY22 aided by the pick-up in commercial activities across geographies. For the quarter ending September 2021, our total operating revenue grew by 9% on a sequential basis to Rs 143 crores reflecting uptick in volumes and the price escalation benefit in our tipping fees. EBITDA has risen by 2% sequentially to Rs. 42.4 crores as compared to Rs. 41.7 crores in previous quarter. The price escalation clause helped maintain our EBITDA margin around 27%. Consolidated PAT has increased by 6% YoY to Rs. 23.6 crores as compared to Rs. 22.3 crores in Q1FY22.

During the quarter, we registered volume growth of 12% and 4% in MSW C&T business as well as MSW processing business respectively as compared to Q1 FY22. The groundwork / pre-operating activities at our Greater Noida bio-mining project are progressing well and we expect that it will start contributing to revenue from current quarter.

Various municipal corporations are moving forward with their tendering process for new MSW C&T contracts, and we are hopeful to report on the development on the same by the end of the current fiscal year. On the MSW Processing front, our existing projects at Kanjurmarg and PCMC continue to perform well.

With pandemic situation cooling down, we expect the volume growth to accelerate further from hereon. With our strong execution capabilities as well as technological prowess developed over two decades, we are well poised to capture the tailwinds that the Municipal Solid Waste Management sector will witness over a medium to long term period.”
