ASTRAZENECA ADMITS TO COVISHIELD SIDE EFFECT

Cong slams Centre for not maintaining data of people who took Covid vaccine

GUJARAT CONGRESS president Shaktanand Gohil on Wednesday accused the BJP-led Centre of ignoring the World Health Organisation's (WHO) emergency guidelines to maintain a database of people who have been administered Covid-19 vaccines.

Gohil's remarks came a day after global pharmaceutical manufacturer AstraZeneca admitted its Covid-19 vaccine, Covishield — developed by researchers from Oxford University — cause Thrombosis with

In India, the AstraZeneca vaccine was manufactured by the Pune-based Serum Institute of India

Thrombocytopenia Syndrome (TTS), a rare side effect of blood clotting and low platelet count after immunisation.

According to reports, AstraZeneca made the admission of this rare side effect in court, as it faces a lawsuit alleging deaths caused by the vaccine. In 2023, the WHO stated that

TTS emerged as a new adverse event following Covid-19 vaccination.

In India, the AstraZeneca vaccine was manufactured by the Pune-based Serum Institute of India (SII) and around 175 crore doses of the same were administered. Citing severe health issues leading to cases of brain stroke, heart attack, kidney and liver failure among young individuals, the Congress lashed out at the government for putting people's lives at stake.

"Several questions are raised on how the government administered Covishield vaccines. Despite the WHO alerting countries in 2023 regarding emer-

gency guidelines to maintain a database of people being administered the Covid-19 vaccine, why did our country not act, whereas every country followed these guidelines," Gohil asked in a press conference.

He also questioned the government for not asking the Central Research Institute, established in 1905, to manufacture the vaccine and instead gave the contracts to SII and Hyderabad-based Bharat Biotech, which manufactured India's indigenous Covid-19 vaccine Covaxin. "When we have a pioneer institution in vaccine like the 118-year-old Central Research Institute, whose work has been

lauded by other countries, why one company, Serum Institute of India, was given the contract? The government gave Rs 3,000 crore advance to Bharat Biotech and Rs 1,500 crore to Bharat Biotech," the Rajya Sabha MP said.

Demanding compensation for all those who died of health complications after being vaccinated, Gohil said, "We have registered this issue. This is criminal negligence. We believe this matter will go to court under Indian Penal Code Section 304 (culpable homicide — not amounting to murder). We expect suo motu action by the high court and the Supreme Court."

ALLEGATIONS OF SEXUAL HARASSMENT, QUEERPHOBIA AT GNLU

High Court takes on record registrar's apology, will suggest steps to make campus safer

AFTER TAKING suo motu cognisance of news reports of alleged incidents of sexual harassment and queerphobia at the Gujarat National Law University (GNLU) in September last year, the Gujarat High Court on Wednesday disposed of the related public interest litigation as it took on record the varsity's registrar's apology.

The bench of Chief Justice Sunita Agarwal and Anirudhja Mayee orally remarked that the court will be passing a detailed order, incorporating some suggestions for the varsity to make the campus safer for its students.

GNLU registrar Jagadeesh Chandra TG offered his unconditional apology to the court on Wednesday for being initially dismissive of the allegations by terming them to be "devoid of any substance".

The bench had taken adverse note of the registrar's stance at the time, recording that he was making an "over anxious effort to hush the whole matter in a summary way".

Apologising for the contents of his affidavit filed on October 10, 2023, soon after the court had taken suo motu cognisance of the incidents, his apology affidavit stated that he had "no intention" to disregard the incidents of sexual harassment at the university which are of "grave nature".

GNLU's registrar Jagadeesh Chandra TG offered his unconditional apology to the court on oath on Wednesday for being initially dismissive of the allegations.

He said he had only made such submissions in his earlier affidavit "in the quest of defending the respondent university (GNLU) with utmost sincerity".

Acknowledging that the litigation is in public interest and not adversarial in nature, Jagadeesh assured in his affidavit that he will henceforth be "extra diligent and exercise extreme caution, great care and restraint" not only in filing affidavits but while discharging his duty.

Chief Justice Agarwal, meanwhile, orally remarked that the bench will be recording its order that he be never given the charge of registrar.

"He is not fit to be a registrar. He may be fit to be a professor. Every person cannot do administrative duties, many are not fit for it," the Chief Justice said.

Vadodara vendor 'assaulted' by cops, probe initiated

TWO DAYS after an omelette vendor in Vadodara was allegedly assaulted by three personnel of a PCR (police control room) van following an altercation, a probe has been initiated into the incident, officials said on Wednesday.

The vendor, identified as Mohamman Faizan Amiruddin Shaikh, 26, is currently admitted in a private hospital following the alleged assault, police said.

According to the two FIRs lodged at Savajigunj police station, the incident occurred at 2:15 am on Monday when the PCR van of Savajigunj police station was patrolling the area outside platform-6 of the Vadodara railway station.

Mohamman Faizan Amiruddin Shaikh allegedly got into an argument when the PCR van pulled up near his cart. He was asked to shut shop,

and give an explanation for violating prohibitory orders. According to eyewitnesses quoted in the FIR lodged by Faizan's older brother Mumtaz, the argument escalated into an assault.

The FIR lodged by Mumtaz van following an altercation, who informed him about the injuries sustained by his brother, said, "Angered by the police abuse and assault, Faizan blocked the way of the PCR van by standing in front of the vehicle and preventing it from leaving."

The policemen, who were in a hurry to escape the scene, as a crowd had gathered in support of Faizan, attempted to drive back, pushing Faizan back upto 100 feet before he fell under the van and sustained injuries.

On Wednesday evening, Assistant Commissioner of Police A Division D J Chavda said, "Usually by 11:30pm - 12am every night, police patrol vans across the city ensure that food

ment and led to a fight. The personnel in the PCR van used the needed physical force and he has been injured. Faizan too attacked the police personnel on duty. We have registered two FIRs and are probing the incident."

The three personnel, including a contractual police driver, have been identified as named Lok Rakshak Mubashir Mohammad Salim and Raghubir Bharatbhai and driver Kishan Parmar. The FIR lodged by Salim states that Faizan allegedly pulled him and jumped on the bonnet of the moving van, leading to the injuries.

The FIR states, "He pulled my uniform and slapped me, prompting Raghubir and Kishan to step in to help me... He threatened us with dire consequences and when we tried to leave from the spot, he jumped onto the bonnet of the van and fell off a few metres ahead, leading to injuries."

Police said it is gathering evidence to probe the case and a disciplinary action will also be initiated against the police personnel. "We have already begun collecting evidence at the crime scene. We have called in forensic experts and conducted a panchnama. We are trying to find CCTV footage... Disciplinary action will also be initiated against the police personnel. Faizan is yet to regain consciousness and is currently admitted at a private hospital. We will record his statement and take legal opinion regarding the arrest of the police personnel as per the probe findings..." ACP Chavda said.

While Salim, Raghubir and Kishan Parmar have been booked under Indian Penal Code (IPC) section 323 (punishment for voluntarily causing hurt), among others, Faizan has also been booked under section 186 (voluntarily obstructing any public servant in the discharge of his public functions) and other sections.
