In exercise of the powers conferred by sub-section (1) of section-11 of The Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013(30 of 2013) (here in after referred to as "The Act") the Government of Gujarat hereby declares that the land/lands mentioned in the Schedule annexed hereto is/are required for the purpose of Ishvariya-Giriya Road (V.R.)
