**Subject: Clarification w.r.t. wrong/duplicate submissions under regulation 7(2) of SEBI (PIT) Regulations, 2015.**

This is in reference to captioned subject, we would like to draw your attention that the Company has tried to make announcement under regulation 7(2) of SEBI (PIT) Regulations, 2015 on Monday, December 11, 2023 for the sale of 4214326 Equity shares of Axita Cotton Limited ("**the Company**"). However due to technical glitch of the site, information of previous announcements already submitted with the exchange got fetched in the XML file instead of current disclosure and the same was uploaded under common XBRL tab & got disseminated on the NSE portal.

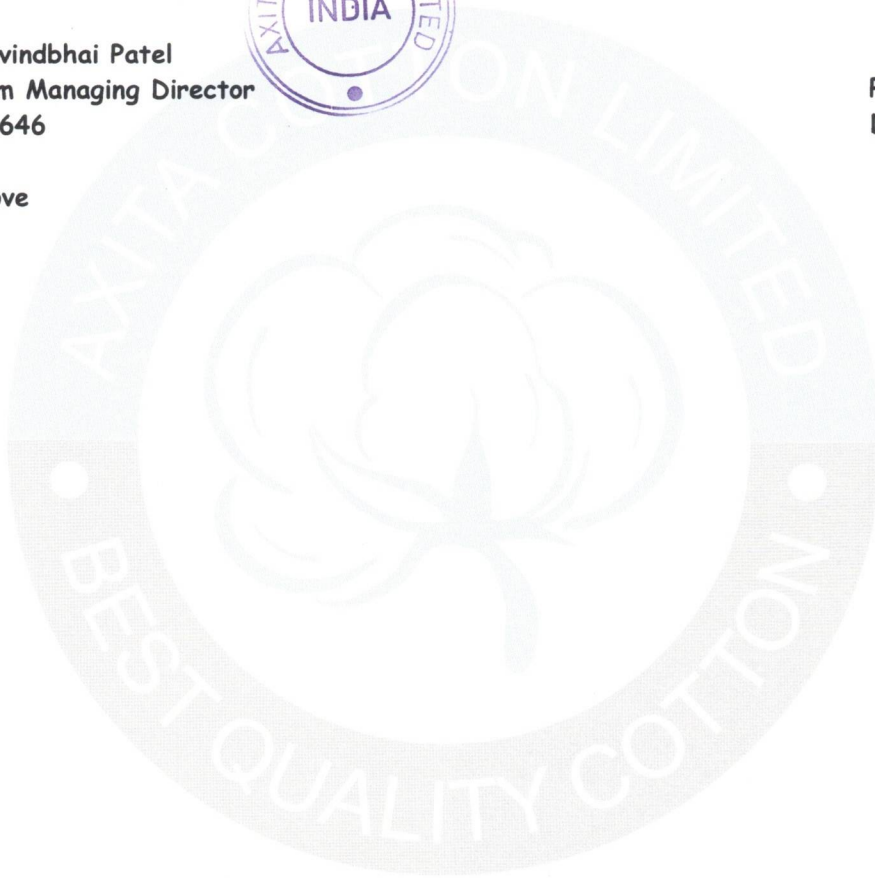
