Sub: Disclosure under Regulation 30 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 - Temporary disruption of operations due to flooding

Pursuant to Regulation 30 read with Para B, Part A of Schedule III of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 ('SEBI Listing Regulations'), this is to inform you that the operations at certain manufacturing facilities and warehouses of the Company at various locations has been temporarily impacted due to incessant rainfall and severe waterlogging in the said facilities and their adjoining areas.

The Company immediately took necessary precautionary measures to ensure the safety of its employees, plant & machinery, materials and other assets. The Company is presently undertaking an assessment of the impact of waterlogging at the said facilities, including the extent of any damage to assets and inventory. The financial impact, if any, is presently being assessed. However, Company has adequate Insurance Coverage.
