Dear Sir / Madam,

Pursuant to Regulation 30 read with Para A of Part A of Schedule III of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, we hereby inform you that a search and seizure operation was conducted by the Income-tax Department at the Company's registered office and certain group entities' premises situated at Ranchi, Jharkhand.

The search operation was carried out under the provisions of Section 132 of the Income-tax Act, 1961 and was initiated on January 29, 2026 and concluded on February 02, 2026, as per the Panchanama issued by the Income-tax Authorities.

During the course of the search proceedings, the Income-tax Authorities carried out verification of records and identified, inventorised and seized certain books of account, loose papers, documents, electronic records and other related materials, which, as informed, are proposed to be examined as part of further tax proceedings in accordance with applicable law.

The Company and its officials extended full cooperation to the authorities throughout the conduct of the search proceedings. Statements of certain employees and representatives of the Company were recorded by the authorities during the course of the proceedings.

At present, the Company has not received any assessment order, demand, penalty notice or formal findings pursuant to the said search proceedings. The Company is in the process of reviewing the matter, including the contents of the Panchanama and related records, and shall take appropriate steps, including seeking professional and legal advice, as may be required.

The Company continues to operate its business in the normal course, and based on the information presently available, the said search proceedings are not expected to have any material adverse impact on the financial position or operations of the Company. The impact, if any, shall be assessed upon completion of further proceedings by the Income-tax Authorities.

The details as required under Clause 19 of Para A of Part A of Schedule III of the SEBI LODR Regulations are enclosed herewith as Annexure A.
