Sub: Outcome of Board Meeting held on June 24, 2025

1. Pursuant to Regulation 30 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("Listing Regulations") as amended and read with SEBI Master Circular No. SEBI/HO/CFD/PoD2/CIR/P/0155 dated 11th November 2024, we would like to inform you that the Board of Directors of the Company, at its meeting held today, based on the recommendation of the Nomination, Remuneration and Corporate Governance Committee, recommended the appointment of Mr. Naveen Pandey (DIN: 09584377) as Additional Director designated as Managing Director of the Company for a period of five consecutive years with effect from July 1, 2025, subject to the approval of the members at the ensuing 19th Annual General Meeting.

Further, there are no *inter-se* relation between Mr. Pandey and the other members of the board. The Company has also received declaration from Mr. Pandey to the effect that he is not debarred from holding the office of Director by virtue of any Order passed by the Securities and Exchange Board of India or any other statutory authorities.

2. Mr. Jaideep Nandi was appointed as the Managing Director of the Company for a term of five years with effect from July 1, 2020. Accordingly, his tenure as Managing Director will conclude on June 30, 2025.
