Pursuant to the provisions of Regulation 30 (read with sub-paragraph 8 of Paragraph B and/or sub-paragraph 20 of Paragraph A, Part A of Schedule III) of the SEBI Listing Regulations, as amended, and in accordance with the Company’s Policy on the Determination of Materiality for the Disclosure of Events or Information, and further to the last updated status submitted by the Company in the ‘Integrated Corporate Governance Report’ (under Disclosure of Updates to Ongoing Tax Litigations or Disputes) for the quarter ended December 31, 2024, regarding an ongoing tax dispute with the State Appellate Authority, Punjab CST, involving an alleged tax demand of Rs.7.56 crore (arising from the Learned AO’s disallowance of submitted statutory forms), **we wish to inform you that, upon representation made in this matter, the Company has received a physical copy of the rectification order dated November 20, 2024, for FY 2016-17, at 11:49 a.m. today, whereby the above tax demand has now been reduced to Rs.50,234/- (including interest of Rs.16,292/-).**
