Dear Sir/Madam,

With reference to the clarification sought by the Exchange vide Announcement No. 106495717 dated 13 January 2026, we have already submitted our response as under:

At the time of selecting the reporting period in the XBRL utility, the half-yearly period was inadvertently selected. Consequently, half-yearly figures were uploaded instead of the quarterly figures for the quarter ended 30 September 2025. The same occurred unintentionally and was purely an oversight at the time of filing. Thereafter Company has re-submitted the corrected XBRL financial results on BSE and NSE portal.

Dear Sir/Madam,

This is with reference to your email regarding the discrepancy in Outcome of Board Meeting-Financial Results submitted to the Exchange on November 14, 2025 of Bang Overseas Limited, wherein it has been observed that half yearly figures included in the XBRL submission instead of quarterly figures.

With regard to the above observation, we would like to clarify that at the time of selecting the reporting period in the XBRL utility, the half-yearly period was inadvertently selected, hence half-yearly figures were uploaded instead of quarterly figures. The same occurred unintentionally and was an oversight at the time of filing.

Upon identifying the inadvertent, the Company has submitted the revised and corrected XBRL filing on November 26, 2025 with the quarterly figures. We further confirm that the Board-approved financial results are quarterly results, as correctly submitted in the PDF filing the Exchange.

We regret and assure you that adequate checks shall be implemented to avoid recurrence of such discrepancies in future.
