## Banka BioLoo Limited Reports Strong Q2 FY 24-25 Results, Highlighting Key Project Wins and Growth Outlook

[Hyderabad, 13/11/2024] – Banka BioLoo Limited (BBL), a leader in sustainable water and wastewater management solutions, has announced its financial results for the second quarter of FY 24-25, showcasing significant growth and promising future developments.

In Q2, Company secured INR 2,100 lakhs in new orders across the Railways and WaSH sectors, bringing total order bookings for the fiscal year to INR 5,100 lakhs. Key contracts included orders from North Frontier Railways, a large residential sewage treatment plant, and a long-term operations and maintenance (O&M) contracts. The company's total unexecuted order book now stands at INR 12,400 lakhs.

Q2 marked our entry into the Bangalore market through a new partnership with Brigade Group, where we will provide sewage treatment as a service. We anticipate strong growth potential from this expansion into the region.

In Q2, BBL's standalone revenue rose by 34% year-on-year, increasing from INR 1,072 lakhs to INR 1,442 lakhs. For the first half of the fiscal year, revenue grew by 29% year-on-year, reaching INR 2,699 lakhs from INR 1,904 lakhs. Additionally, the company achieved a half-yearly Profit Before Tax and exceptional items of INR 105.7 lakhs, compared to INR (-82.5) lakhs in the same period last year, underscoring its focus on growth and profitability. This quarter, Company took one-time exceptional provisions of INR (-712.2) lakhs due to losses in its subsidiary, bringing the half-year Profit After Tax (PAT), inclusive of provisions, to INR (-610) lakhs.

Looking forward, Banka BioLoo will continue to prioritize cash flow and cost management to maximize its robust order book and sustain growth.
