Pursuant to Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulations 2015, this is to inform that Bansal Wire Industries Limited (Company) has received Show Cause Notice (SCN) for Goods & Services Tax, Interest and Penalty under Section 74 of the CGST/ SGST Act, 2017 for the financial year 2021-22 which was communicated on November 05, 2025.

The Company is of the view that the Show cause notice is untenable and has no merits, and the Company is reviewing the SCN and evaluating its compliance obligations and hence, this disclosure is being made timely by the Company in compliance with Regulations 30 read with Para B of Part-A of Schedule III of SEBI LODR 2015, as amended, read with related SEBI Circulars issued in this regard.

However, as per SEBI guidelines, we are making this disclosure to ensure transparency and to keep the investors informed, we do not expect any material financial impact on the Company, given the expected reduction in the penalty and the settlement process. We will be filing appropriate response to the said notice within the prescribed timelines with the appropriate authority.

The details as required under Regulation 30 of the Listing Regulations is attached as **Annexure – A**. There is no material impact on financials, operations or other activities of the Company.

On November 04, 2025, Bansal Wire Industries Limited ('Company') has received a Show Cause Notice ('SCN'), issued by Joint Commissioner, SGST, Corporate Circle, Ghaziabad (A) Uttar Pradesh. The SCN is issued under Section 74 of SGST/ CGST Act, 2017 pertaining to FY-21-22 in connection with issues involving availment of blocked and excess ITC, non-payment of tax on sale of RODTEP license. The Company strongly believes that the Tax, Interest and penalty as alleged by the department should not be levied on the Company.
b.	Expected financial implications, if any, due to compensation, penalty etc.	The Company is of the view that the Show cause notice is untenable and has no merits, and the Company shall make its appropriate response before the Authority within the given timelines. There is no material impact on financial, operational, or other activities of the Company arising from the said SCN.
