HYDERABAD: BRS Working President K T Rama Rao expressed deep grief over the death of several Hyderabad pilgrims in a horrific bus accident in Saudi Arabia and urged the Telangana Government to act swiftly to support the affected families.

were from Hyderabad, he said the government must work closely with the Ministry of External Affairs to intensify relief operations and gather accurate information about the victims. KTR also stressed the need to identify all those who died in the tragedy and extend every form of assistance to their families. Acting on his instructions, a group of BRS minority leaders will travel to Saudi Arabia to support the bereaved families.

Youth must enter politics to uphold Patel's ideals: Bandi Sanjay

Karimnagar, Nov 17 : union Minister of State for Home Affairs Bandi Sanjay Kumar urged young Indians to step into public life, warning that the rise of hereditary politics would weaken the nation and drift it away from Sardar Vallabhbhai Patel's vision of a united, progressive India.

Taking part in a massive padayatra from Essarar College in Karimnagar as part of the nationwide 'Sardar@150 Unity March', Sanjay said India cannot afford to fall behind in global competition, and that the active participation of youth in politics is essential for the country's future. Thousands

of students and youngsters joined him in the march, organised to mark Patel's 150th birth anniversary. Addressing the media at the start of the rally, alongside MLCs Malka Komaraiah and Anji Reddy, District Collector Pamela Satpati and Police Commissioner Ghaus Alam, Sanjay reminded that Patel was the architect of India's unity, integrating 560 princely states and liberating Hyderabad through 'Operation Polo'.

He said Patel's decisive leadership prevented Telangana from being pushed into a bleak future under the Nizam, which, he warned, could have turned the region into "another Pakistan or Sri Lanka" had it not merged with India.



Massive Infrastructure Boost for Miryalaguda Ministers Launch Works Worth 171.5 Crore



Hyderabad: In a significant push to infrastructure and civic development, Telangana Ministers Komatireddy Venkat Reddy (Roads & Buildings, Cinematography) and Nalamada Uttam Kumar Reddy (Irrigation & Civil Supplies) on Monday laid foundation stones and inaugurated multiple development works totalling 171.5 crore in Miryalaguda constituency. They were accompanied by Nalgonda MP Kunduru Raghuvver Reddy.

A major highlight of the visit was the launch of the 74-crore four-lane road from Shettipalem to Avantipuram, aimed at easing traffic flow and improving regional connectivity. The Ministers also inaugurated a 15-crore TFUIDC road, a 16-crore CC road, and several drainage improvement projects. Civic infrastructure works worth 41 crore, including BT and CC roads across Miryalaguda municipality, were also initiated. Foundation stones were laid for the six-lane expansion of the Miryalaguda-Thadakamalla double road (15 crore) and beautification works around the flyover and municipal office (3 crore). Newly constructed

academic blocks at KNM Degree College (5 crore) and Government Junior College (2.25 crore) were inaugurated.

Addressing a public meeting, Irrigation Minister Uttam Kumar Reddy said the government is ensuring uninterrupted irrigation water supply and is committed to completing all pending lift irrigation schemes in Miryalaguda. He reiterated that Telangana remains the only State providing 6 kg of fine rice per person, and assured ration cards to all eligible beneficiaries. He promised fast procurement of paddy with payments credited within 72 hours, along with continued welfare measures such as free electricity and free bus travel for eligible sections. He reaffirmed the government's commitment to implementing 42% BC reservations.

The Minister announced 57 crore for main canal lining works, 24 crore for new check-dams at Dubb Thanda, Shantinagar and Ravulapenta, and 20 crore for feeder channel development. Five ongoing lift irrigation projects will be fast-tracked, he added.
