Telangana to launch first phase of Indiramma Housing Scheme in Hyderabad



Hyderabad, May 27 (UNI) Telangana Revenue and Housing Minister Pongelti Srinivasa Reddy on Wednes-

day announced that the State Government would soon launch the first phase of the Indiramma Housing Scheme in Hyderabad with a target of

and Mohammed Ali Shabbir, Pongelti said over one lakh houses had already been completed across the state under the Rs 22,500-crore Indiramma Housing programme, while another one lakh houses would be completed by the end of June. The Minister said only 18,000 houses were initially sanctioned under GHMC limits due to a shortage of land, but the government has now identified nearly 38 to 39 locations inside the Outer Ring Road for the construction of houses in areas close to the beneficiaries' livelihoods. He said the government was committed to constructing houses in the same localities where poor families currently reside instead of shifting them to distant outskirts. Pongelti stated that the houses would be registered free of cost in

Asara pensions to Singareni workers. The CPI leader also announced state-wide protests against rising petrol and diesel prices, accusing the Centre of burdening common people with repeated fuel hikes. He further demanded regulation of fee structures in corporate educational institutions and hospitals, while calling for stronger action in control drug-related issues in the state. Union leaders Vaseddy Seetharamiah and Raj Kumar alleged excessive political interference in Singareni affairs and accused successive governments of neglecting the organisation. They claimed that no new mines had been allotted to Singareni after the formation of Telangana and raised concerns over outsourcing and workers' welfare. The leaders warned that the union would intensify protests and launch a strike if the government failed to implement corrective measures within the stipulated timeframe.

Hyderabad, May 27 (UNI) Communist Party of India (CPI) Telangana State Secretary and MLA Kunamneni Sambasiva Rao on Wednesday warned that Singareni workers would be forced to go on strike if their demands are not addressed by the second week of June. Addressing a press conference at the CPI State Office in Himayat Nagar, Sambasiva Rao said the government must protect Singareni Collieries, which he described as the "heartbeat of Telangana," and focus on

the welfare of workers along with the organisation's development. He alleged that the government was withholding Rs 56,000 crore dues owed to Singareni and demanded a White Paper on the company's financial condition. He criticised the reduction of permanent employees and alleged exploitation of contract workers through low wages and excessive workload. He demanded equal wages on par with Coal India standards, restoration of jobs under the medical invalidation scheme, and extension of
