Reg: Report on the Postal ballot process for the resolutions as set out in the Notice of Postal Ballot dated 30th June, 2025

Sir

- 1. The board of directors of Bannari Amman Spinning Mills Limited ("the Company") (CIN: L17111TZ1989PLC002476) at its meeting held on 30th June, 2025, appointed me as a Scrutinizer to scrutinize the Postal Ballot Process (voting by e-voting) and issue a report in connection with the subject matter.
- 2. I submit my report as under:
- a. As per General Circular Nos. 14/2020 dated April 8, 2020, 17/2020 dated April 13, 2020, 20/2020 dated May 05, 2020, 22/2020 dated June 15, 2020, 33/2020 dated September 28, 2020, 39/2020 dated December 31, 2020, 10/2021 dated June 23, 2021, 20/2021 dated December 08, 2021, 03/2022 dated May 05, 2022, 11/2022 dated December 28, 2022 and 09/2023 dated September 25, 2023, 9/2024 dated September 19, 2024 issued by the Ministry of Corporate Affairs, Government of India (the "MCA Circulars"), Secretarial Standard on General Meetings ("SS-2") issued by the Institute of Company Secretaries of India, the Company has sent the Postal Ballot Notice dated 30th June, 2025 through electronic mode to the members whose names appeared in the Registrar of Members/list of beneficial owners as on cut-off date i.e 30th June, 2025.

- b. Further, a corrigendum to the notice of Postal Ballot dated 30th June, 2025 was given to the shareholders through e-mail on 17.07.2025 and also through News Paper advertisement (Business Standard dated 19th July, 2025 and Makkal Kural dated 19th July, 2025) and an option was given to shareholders, who have already voted before the issue of the aforesaid corrigendum notice, to give their assent or dissent on the resolution by sending an email to me at sharpcs1@gmail.com.
- c. As the Postal Ballot process was conducted only through remote e-voting system pursuant to the above referred circulars, no Postal Ballot forms were required to be sent by the Company.
- d. Particulars of all votes cast through electronic mode have been entered in the Register separately maintained for the purpose in electronic mode.
- e. Since there was no voting by physical postal ballot form, the question of keeping them in my safe custody before commencing the scrutiny does not arise.
- f. The votes cast through electronic means were unblocked after 5.00 P.M. on 31st July, 2025.
- g. In response to the corrigendum notice referred to above, I have not received any assent or dissent from shareholders have already voted before the issue of the aforesaid corrigendum notice, in respect of the resolutions set out in the Postal Ballot Notice dated 30th June, 2025 through my email id sharpcs1@gmail.com up to 5.00 P.M. on 31st July, 2025.
- h. Votes cast through electronic means were scrutinized and the shareholding was matched with the Register of Members of the Company / list of beneficiaries as on the cut-off date (30th June, 2025).
- i. Votes cast through electronic means up to 5.00 P.M of 31st July, 2025, being the last time and date fixed by the company for voting through electronic means were considered for my scrutiny.
- j. Since the voting on Postal ballot Process was conducted only through e-voting, reporting on number of envelopes containing postal ballot form received after due date and up to the date of this report does not arise.

- k. Since the voting on Postal ballot Process was conducted only through e-voting, reporting on number of envelopes containing postal ballot form returned undelivered also does not arise.
- 1. Since the voting on Postal ballot Process was conducted only through e-voting, reporting on finding of defaced or mutilated ballot papers also does not arise.
