With regard to the above applicability of said regulation we hereby inform you that during Financial Year 2021-22 our company is listed on NSE EMERGE (SME Exchange). Therefore, we are not required to submit a secretarial Compliance Report for the Year Ended on March 31st, 2022 to NSE India Limited.
