Brightcom Group on Saturday disclosed their results for the quarter that ended on December 30, 2023. While the company reported a net loss, its revenue also grew by 85% from the same period last year.

Brightcom Group attributed this performance to the war in Israel, the departure of its CEO and CFO, the "negative media coverage" post the SEBI order and the multiple challenges faced by the company due to these turn of events.

The Brightcom Group's income statement shows a net loss of ₹24.2 crore for the October-December quarter of the previous financial year. That is in comparison to a net profit of ₹544 crore that has been reported in the same quarter of financial year 2023.

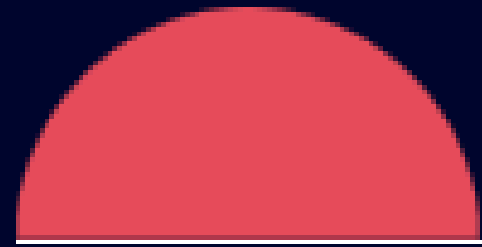
