NSE/LIST-SOP/FINES/0709 dated 27th June, 2025, imposed fine of Rs. 70,800/- (Seventy Thousand Eight Hundred Rupees) on the Company. The fine has been levied under Regulation 33 of the SEBI Listing Regulations due omission to disclose the Standalone Reconciliation of profit and loss for the half year ended on 31st March 2025.

The omission has occurred unintentionally & due to human error. The Company is actively working to prevent such occurrences in the future, including reinforcing internal procedures to ensure timely submissions. and remains fully committed to ensuring compliance with all applicable laws and regulations.
