# Vidyuth, Nitin Sai Yadav shine

## TNCA President's XI Hyderabad reach Buchi Babu final

Chennai, Sep 4:

The semifinals of the All India Buchi Babu Invitation Cricket Tournament 2025 concluded on Wednesday, with TNCA President's XI and Hyderabad securing their spots in the final. Both matches saw dominant bowling performances from young talents, with P. Vidyuth of TNCA President's XI and Nitin Sai Yadav of Hyderabad each claiming a seven-wicket haul.

In the first semifinal at CSK-HPC, TNCA President's XI defeated Jammu & Kashmir. Resuming their first innings at 212/4, Jammu & Kashmir were bowled out for 230, conceding a massive first-innings lead of 337 runs. P. Vidyuth was the wrecker-in-chief for TNCA President's XI, finishing with impressive figures of 7 for 73, his second five-wicket haul of the season and his best performance in the tournament. Due to the significant deficit, Jammu & Kashmir conceded the match after the first innings. Vidyuth was rightly named Player of the Match for his stellar performance.

In the other semifinal at the Guru Nanak College Ground, defending champions Hyderabad triumphed over Haryana in a closely contested match. Hyderabad posted scores of

225 and 254 in their two innings. In response, Haryana was bowled out for 208 and 181, falling short by 90 runs. Nitin Sai Yadav was the star performer for Hyderabad, with his devastating spell of 7 for 44 in the second innings. Yadav, who had two wickets overnight, added five more to his tally on the final day, helping Hyderabad secure the victory. Varun Goud of Hyderabad was named the Player of the Match. ## 114 GMs in fray at FIDE Grand Swiss chess

Top seed Indian star Praggnanandhaa Rameshbabu will lead the field in the FIDE Grand Swiss Tournament 2025 organised by FIDE & Uzbekistan Chess Federation runs from September 4 to 15 at Samarkand, Uzbekistan. One of the strongest Opens ever the event boasts of 114 Grand Masters from 33 countries. The winner and runner-up of the 11-round FIDE Grand Swiss 2025 will earn the right to play in the Candidates Tournament 2026.

The participation of World Champion Gukesh Dommaraju adds glitter to the FIDE Grand Swiss tournament, while fellow Grand Master and FIDE Circuit leader Praggnanandhaa Rameshbabu will take off as the top seed. Completing the 1-2-3 Indian line up of tournament seeds will be GM Erigaisi

Arjun who will look forward to locking his Candidates spot here. Some of the favorites who will be hungry to make the cut will be GMs Firouzja, Keymer, Abdusattorov, Giri, Aronian, Nepomniachtchi, Mamedyarov, MVL, Niemann among others. FIDE president Arkady Dvorkovich speaking at a press conference, said, "The Grand Swiss is the strongest open competition in the two-year World Championship cycle, allowing all top players to fight for the spots in the Candidates tournaments. There are no weak opponents here and everything is usually decided in the last round, which will bring huge excitement for the spectators".

World Champion Gukesh Dommaraju quipped, "I'm happy to be back here in Samarkand. I was here in 2023 for the World Rapid and Blitz. It's nice to be back here. Although

there's no need for me to qualify, I think this is still a great tournament. There are not many super strong open Swiss tournaments. It's an opportunity for me to play in a different format and prove myself." Present in the dais on the occasion of the press meet were World Champion Gukesh Dommaraju, Uzbek Minister for Youth Policy and Sports Adham Ikramov, Uzbek first vice president Alisher Sadullaev and WIM Afruza Khamdamova.

FIDE commentator for the event, GM Evgenij Miroshnichenko highlighted five reasons to watch and not miss this gala viz., (1) Reigning world champion, ex-world champion, Candidates players in action, (2) There's always going to be something going on, (3) Unpredictability, (4) Young upcoming players will impress and (5)
