Pursuant to Regulation 30 read with Sub-Para 20 of Para A of Part of A of Schedule III of the Listing Regulations and the relevant clauses in relation to Events which shall be disclosed without any application of the guidelines for materiality as specified in sub-regulation (4) of regulation (30), we wish to inform you that Joint Commissioner, Central Goods & Services Tax, Gautam Buddha Nagar has confirmed a demand of Rs.6,51,09,802/- (CGST-Rs.3,25,54,901/- & SGST-Rs.3,25,54,901/-) (Rupees Six Crore Fifty One Lakh Nine Thousand Eight Hundred Two only) under Section 74 of the CGST Act, 2017 and UPGST Act, 2017 read with Section 20 of the IGST Act, 2017 in respect of a case pertaining to July 2017 to March 2023 and has imposed equivalent penalty of Rs.6,51,09,802/- (CGST-Rs.3,25,54,901/- & SGST-Rs.3,25,54,901/-) (Rupees Six Crore Fifty One Lakh Nine Thousand Eight Hundred Two only) in relation to interpretational issues viz. rate of GST leviable on supply of Kulcha and chocofill Bun.

The company will file an appeal in relation to the same.
