Sub: Disclosure under Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 (“SEBI Listing Regulations”)

With reference to captioned subject and our earlier intimation dated March 14, 2025, we would like to inform that the Company has received an email dated March 28, 2025 from National Stock Exchange of India Limited (“NSE”) and BSE Limited (“BSE”) with respect to non-compliance of the Regulation 33 of Listing Regulations.

The Company wish to clarify that the non-compliance has occurred as the Nandi Infrastructure Corridor Enterprise Ltd. (NICE) and Nandi Economic Corridor Enterprises Ltd. (NECE), Subsidiaries of the Company, have not yet submitted their Unaudited Financial Results for the quarter ended December 31, 2024 to the Company.
