**11<sup>th</sup> July 2013, BGR Energy Systems Limited**, a leading EPC and BoP company in the power industry has signed today a Balance of Plant (BoP) contract with Odisha Power Generation Corporation for OPGC's coal based Super Thermal Power Project - 2x660MW project at Banaharpalli in Jhasarguda district of Odisha.

BGR Energy emerged as the lowest L-1 bidder in an international competitive bidding competing against L&T, TATA Projects, and Essar Projects. The ₹ 1573 Crore order comprise two 660MW supercritical units to be completed in 44 months and 48 months respectively. The scope includes Design, engineering, manufacture, procurement, supply, inspection, testing, commissioning and performance testing of Balance of Plant Works.

OPGC started as a wholly owned company of the Government of Orissa (the "GoO") with the main objective of establishing, operating and maintaining large thermal power generating stations. As a part of the reform process in the energy sector, GoO divested 49% of the equity in favor of AES Corporation of USA (AES) in early 1999. AES is engaged in the business of developing, financing, constructing, owning and operating power generating facilities around the world.
