1. The above Financial results for the Quarter ended Dec 31, 2025 were reviewed by the Audit Committee and thereafter approved by the Board of Directors at its meeting held on Feb 2nd, 2026. This financial results has been prepared in accordance with Companies (Indian Accounting Standard) Rules, 2015 (IND AS) notified under Section 133 of the Companies Act, 2013 and other recognized accounting practices to the extent applicable.
2. On November 21, 2025, the Government of India notified the four Labour Codes - the Code on Wages, 2019; the Industrial Relations Code, 2020; the Code on Social Security, 2020; and the Occupational Safety, Health and Working Conditions Code, 2020 (collectively "New Labour Codes") - consolidating 29 existing labour laws. The Ministry of Labour & Employment published draft rules and FAQs to enable assessment of the financial impact due to changes in regulations. The Company has assessed the incremental impact of these changes on the basis of the best information available and included the amount of Rs. 188.35 lakhs under employee benefit expense. The company continues to monitor the finalisation of central/state rules and clarification from the government on the other aspects of the labour code and would provide appropriate accounting effect on the basis of such development as per the same.
3. The Company is principally engaged in single segment viz. Manufacturing of wire & wire ropes based on nature of products, risks, return and internal business reporting system.
