With reference to captioned subject and in furtherance of Rights Issue of the Company, this is to inform that in terms of the Letter of Offer dated February 19, 2026 and in accordance with the Basis of Allotment finalized in consultation with BSE Limited (Designated Stock Exchange), and the Registrar to the Issue, the Rights Issue Committee of the Company has, at its meeting held on today, i.e., on Monday, March 23, 2026 approved the allotment of 9,29,06,781 Equity Shares of face value of Re.1/- each issued at a price of Rs. 2.56 per Equity Share (including a share premium of Rs. 1.56 per Equity Share) as per the Basis of Allotment finalized.

The Company shall initiate the process of Listing of the shares allotted under the Right issue in due course. With this allotment, the paid up Equity Share Capital of the Company stands increased from Rs. 24,00,49,652 (Rupees Twenty Four Crores forty nine thousand six hundred and fifty two) to Rs. 33,29,56,433 (Rupees Thirty Three Crores, twenty-nine lacs, fifty-six thousand, four hundred and thirty-three).
