In terms of provisions of Regulation 30 (read with Part A of Schedule III) and other applicable provisions of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 (Listing Regulations), this is to inform you that the National Green Tribunal (NGT), vide its Order pronounced dated 29/05/2024 (Order) has directed the Company to deposit an amount of ₹13.30 Crores towards Environmental Damage Compensation (EDC) after adjusting the amount of ₹1.50 Crore which has been already paid by us to Gujarat Pollution Control Board (GPCB) within a period of 1 month from the date of uploading of the Order. Further, NGT has directed GPCB to utilize the said amount for the environmental improvement in the area within 10 Kms. of our Plant situated at Dahej (Gujarat).

The above Order has been passed in respect of a substantial issue relating to the environment arising out of an accident which happened in our factory situated at Plot No. 42/4, Amod Road, GIDC, Dahej, District Bharuch, Gujarat-392130, on 17<sup>th</sup> May, 2022.
