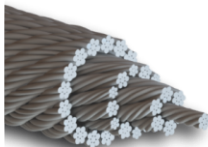

Therefore, the Company believes it is not required to prepare and submit consolidated financial results for its Associate Company for the quarter ended June 30, 2024.</p> <p>Furthermore, the Company is obligated to submit its unaudited quarterly financial results, including consolidated results, to the stock exchanges within forty-five days of the end of each quarter. 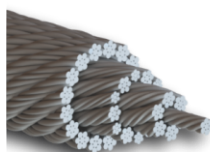
