In terms of Regulation 30 read with Schedule III and other applicable provisions of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 'SEBI (LODR) Regulations', we hereby inform that Bharat Heavy Electricals Limited (BHEL) has received a favourable order for FY-2020-21 from Office of the Commissioner of Customs & Central Tax, Appeals-II Commissionerate Hyderabad, Telangana under the Central Goods and Services Tax Act, 2017 read with Central Goods and Services Tax Rules, 2017.

It is pertinent to mention here that vide the disclosure dated 29.03.2025 the impugned order raising demand amounting to Rs. 10.76 Cr. (along with applicable interest of Rs. 7.74 Cr. and penalty of Rs. 1.07 Cr.) was reported to Stock Exchange under para A of part A of Schedule III of SEBI (LODR) Regulations, 2015. Now, vide the Order dated 17.09.25 passed by Commissioner Appeals, Hyderabad, the proceedings have been settled in favour of the Company by allowing the appeal and setting aside demand of GST along with interest and penalty.
