Arbitration was prescribed to be conducted in accordance with Delhi International Arbitration Centre (Arbitration Proceedings) Rules, 2023 by an Arbitral Tribunal consisting of 3 members</p> <p>Brief details of the matter: RTC had instituted the arbitration proceedings being aggrieved by KRBL Limited (“KRBL’s/ the Respondent”) action of terminating the Distributorship Agreements dated 14 January 2022 and 21 May 2022 and had sought damages and compensations in respect thereof.</p> <p>Current Status: The Arbitral Tribunal after proceedings has delivered its Award on 26 February 2026. The Final Award has ruled in favour of the Claimant i.e., RTC, while also ruling that neither RTC nor KRBL has committed fraud or wilful misconduct.</p> <p>KRBL has initiated the process of obtaining legal advice to challenge the Award under Section 34 of the Arbitration and Conciliation Act, 1996, within the statutory time limit as prescribed under the law</p>
