

Proceedings of the Extra-Ordinary General Meeting of M/s Bikewo Green Tech Limited (Formerly Bikewo Green Tech Private Limited) ("Company") held on Monday, 08th December 2025 at 11:30 A.M, through Video Conferencing ("VC") / other Audio-Visual Means ("OAVM"). The meeting was held in compliance with the general circulars issued by the Ministry of Corporate Affairs (MCA) and circulars issued by the Securities and Exchange Board of India (SEBI) in this regard and as per the applicable provisions of the Companies Act, 2013 and the rules made thereunder.

The meeting commenced at 11:30 A.M. (IST) and concluded at 11:55 A.M. (IST) (including time allowed for e- voting at EGM).

➤ The Extra-Ordinary General Meeting of M/s. Bikewo Green Tech Limited held on Monday, 08th December 2025 at 11:30 a.m. through Video Conferencing ("VC")/ Other Audio-Visual Means ("OAVM"). The meeting was held in compliance with the general circulars issued by the Ministry of Corporate Affairs (MCA) and circulars issued by the Securities and Exchange Board of India (SEBI) in this regard and as per the applicable provisions of the Companies Act, 2013 and the rules made thereunder.











- ➤ Mr. Manideep Katepalli chaired the Extra-Ordinary General Meeting after ascertaining requisite quorum being present; The Chairman extended a warm welcome to all members, and other invitees who joined the meeting through VC.
- ➤ Mr. R. Naresh Babu, member of Secretarial Team on behalf of the Company then introduced the Directors & KMPs of the Company to the members. After that he handed over to Mr. Manideep Katepalli to conduct the proceedings. After ascertaining the presence of the requisite quorum, Mr. Manideep Katepalli, Chairman and Managing Director called the meeting to order and commenced the proceedings of the meeting. The Company Secretary provided general instructions to members regarding participation in the meeting and to cast their votes through insta-poll and confirmed that the Company had taken all feasible efforts under the current circumstances to enable members to participate through VC and vote on the item being considered for the meeting.

Sub: Scrutinizer's Report on e-voting conducted pursuant to the provisions of Section 108 of the Companies Act, 2013 read with Rule 20 of the Companies (Management and Administration) Rules, 2014 as amended by Companies (Management and Administration) Amendment Rules, 2015 and Secretarial Standards on General Meetings for the Extra-Ordinary General Meeting of M/s. Bikewo Green Tech Limited held on Monday, December 08, 2025 at 11: 30 A.M through Video Conferencing ("VC") /Other Audio-Visual Means ("OAVM").

With reference to the above subject, I, Jineshwar Kumar Sankhala, Practicing Company Secretary (P.S Rao and Associates, Company Secretaries) state that I was appointed as a scrutinizer for the Extra-Ordinary General Meeting of the Company, by the Board of Directors of the Bikewo Green Tech Limited pursuant to Section 108 of the Companies Act, 2013 read with Rule 20 of the Companies (Management and Administration) Rules, 2014, as amended, to conduct the remote e-voting process held during the period Friday, 05th December 2025 at 09:00 a.m. (IST) to Sunday, 07th December, 2025 at 05:00 p.m. and e-voting done at the EGM conducted through video conferencing ('VC') / Other Audio Visual Means ('OAVM') mode, held on Monday, December 08, 2025 at 11:30 A.M in a fair and transparent manner, for ascertaining the requisite majority and for giving my report in connection with the item of business as provided in the notice dated 11th day of November, 2025. In this regard I report as under:

1. The notice dated 11th day of November, 2025, as confirmed by the Company was sent to the shareholders through electronic mode to those Members whose email addresses are registered with the Company/ Depositories, in compliance with the MCA circulars circular Nos.14/2020, 17/2020, 20/2020, 02/2021, 21/2021, 2/2022, 10/2022 and 09/2023 (collectively referred to as "MCA Circulars") issued by the

Ministry of Corporate Affairs ("MCA") "and in compliance with the provisions of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("Listing Regulations"), 2015.

- 2. The Company availed the services of M/s. Bigshare Services Private Limited (hereinafter referred to as the "Service Provider") to offer the electronic voting facility to its shareholders. The e-voting facility was offered and kept open by the Company to its Shareholders for the period commencing on Friday, 05th December, 2025 (09:00 A.M) to Sunday, 07th December, 2025 (5:00 P.M.). The shareholders whose names appeared in the Register of Members / List of Beneficial Owners as on Monday, 01st December, 2025 (i.e. cut off date) were allowed to participate and vote electronically on all the items of business during the aforesaid period of e-voting.
- 3. At the EGM of the company held on Monday, December 08, 2025, at 11.30 A.M the company had also provided e-voting facility to such shareholders present at the EGM conducted through VC/ OAVM and had not participated in the e-voting facility provided during Friday, December 05, 2025 from 9:00 A.M to Sunday, December 07, 2025 at 5:00 P.M to cast their votes.
- 4. After the closure of e-voting during the EGM, the voting done at the EGM and the votes cast through remote e-voting facility prior to the EGM were unblocked and reconciled with the records maintained by the company / Registrar and Share Transfer Agents of the company and a combined report has been generated based on the data downloaded from the Bigshare Services Private Limited e-voting system.
- I have scrutinized votes cast by way of remote e-voting and e-voting during the EGM, based on the data downloaded from the Bigshare Services Private Limited evoting system.
- 6. The Management of the Company is responsible to ensure the compliance with the requirements of the Companies Act, 2013 and Rules relating to voting through electronic means on the resolutions contained in the notice to the Extra-Ordinary General Meeting (EGM) of the Equity Shareholders of the Company. My responsibility as a scrutinizer for the e-voting process is restricted to make a Scrutinizer's report of the votes cast "in favour" or "against" the resolutions stated in the EGM notice, based on the reports generated from e-voting system provided by Bigshare Services Private Limited, the authorized agency to provide e-voting facilities, engaged by the Company.
