- Mr. Manideep Katepalli chaired the Extra-Ordinary General Meeting after ascertaining requisite quorum being present; The Chairman extended a warm welcome to all members, and other invitees who joined the meeting through VC.
- Mr. R. Naresh Babu, member of Secretarial Team on behalf of the Company then introduced the Directors & KMPs of the Company to the members. After that he handed over to Mr. Manideep Katepalli to conduct the proceedings. After ascertaining the presence of the requisite quorum, Mr. Manideep Katepalli, Chairman and Managing Director called the meeting to order and commenced the proceedings of the meeting. The Company Secretary provided general instructions to members regarding participation in the meeting and to cast their votes through insta-poll and confirmed that the Company had taken all feasible efforts under the current circumstances to enable members to participate through VC and vote on the item being considered for the meeting.
- The CEO addressed the members, highlighting the company's strategic focus on acquisitions, investments, mergers, and takeovers. Over the next few months, the organization will actively pursue opportunities in the electric mobility sector by acquiring electric two-wheelers (2W) and three-wheelers (3W) from multiple OEMs and deploying them with fleet operators under long-term lease arrangements. In addition, the company will venture into aviation and expand its presence in warehousing and logistics infrastructure, reinforcing its commitment to diversified growth and future-ready business models.

Sub: Scrutinizer's Report on e-voting conducted pursuant to the provisions of Section 108 of the Companies Act, 2013 read with Rule 20 of the Companies (Management and Administration) Rules, 2014 as amended by Companies (Management and Administration) Amendment Rules, 2015 and Secretarial Standards on General Meetings for the Extra-Ordinary General Meeting of M/s. Bikewo Green Tech Limited held on Wednesday, July 22, 2026 at 11: 30 A.M through Video Conferencing ("VC") /Other Audio-Visual Means ("OAVM").

With reference to the above subject, I, **Jineshwar Kumar Sankhala**, Practicing Company Secretary (P.S Rao and Associates, Company Secretaries) state that I was appointed as a scrutinizer for the Extra-Ordinary General Meeting of the Company, by the Board of Directors of the Bikewo Green Tech Limited pursuant to Section 108 of the Companies Act, 2013 read with Rule 20 of the Companies (Management and Administration) Rules, 2014, as amended, to conduct the remote e-voting process held during the period Sunday, 19th July 2026 at 09:00 a.m. (IST) to Tuesday, 21st July, 2026 at 05:00 p.m. and e-voting done at the EGM conducted through video conferencing ('VC') / Other Audio Visual Means ('OAVM') mode, held on Wednesday, July 22, 2026 at 11:30 A.M in a fair and transparent manner, for ascertaining the requisite majority and for giving my report in connection with the item of business as provided in the notice dated 22nd day of June, 2026. In this regard I report as under:

1. The notice dated 22nd day of June, 2026, as confirmed by the Company was sent to the shareholders through electronic mode to those Members whose email addresses are registered with the Company/ Depositories, in compliance with the MCA circulars circular Nos.14/2020, 17/2020, 20/2020, 02/2021, 21/2021, 2/2022, 10/2022 and 09/2023 (collectively referred to as "MCA Circulars") issued by the Ministry of Corporate Affairs ("MCA") "and in compliance with the provisions of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("Listing Regulations"), 2015.

2. The Company availed the services of M/s. Bigshare Services Private Limited (hereinafter referred to as the "Service Provider") to offer the electronic voting facility to its shareholders. The e-voting facility was offered and kept open by the Company to its Shareholders for the period commencing on Sunday, 19th July, 2026 (09:00 A.M) to Tuesday, 21st July, 2026 (5:00 P.M.). The shareholders whose names appeared in the Register of Members / List of Beneficial Owners as on Wednesday, 15th July, 2026 (i.e. cut - off date) were allowed to participate and vote electronically on all the items of business during the aforesaid period of e-voting.
3. At the EGM of the company held on Wednesday, July 22, 2026, at 11.30 A.M the company had also provided e-voting facility to such shareholders present at the EGM conducted through VC/ OAVM and had not participated in the e-voting facility provided during Sunday, 19th July, 2026 from 9:00 A.M to Tuesday, 21st July, 2026 at 5:00 P.M to cast their votes.
4. After the closure of e-voting during the EGM, the voting done at the EGM and the votes cast through remote e-voting facility prior to the EGM were unblocked and reconciled with the records maintained by the company / Registrar and Share Transfer Agents of the company and a combined report has been generated based on the data downloaded from the Bigshare Services Private Limited e-voting system.
5. I have scrutinized votes cast by way of remote e-voting and e-voting during the EGM, based on the data downloaded from the Bigshare Services Private Limited e-voting system.
6. The Management of the Company is responsible to ensure the compliance with the requirements of the Companies Act, 2013 and Rules relating to voting through electronic means on the resolutions contained in the notice to the Extra-Ordinary General Meeting (EGM) of the Equity Shareholders of the Company.
