SUB.: PROCEEDINGS OF THE 38TH ANNUAL GENERAL MEETING OF THE COMPANY HELD ON 29TH SEPTEMBER, 2025

Pursuant to Regulations 30 and 44 read with Para A of Schedule III of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015, please find below the proceedings of the 38th Annual General Meeting (“AGM”) of Bhartiya International Limited (“the Company”):

1. The 38th AGM of the Company was held on Monday, 29th September, 2025 at 11:00 a.m. (IST) through Video Conferencing (VC) / Other Audio-Visual Means (OAVM) facility.
2. The meeting commenced at 11:00 a.m. Mr. Yogesh Kumar Gautam, Company Secretary of the Company, welcomed the members and informed them that the AGM was being conducted through VC in compliance with the circulars issued by the Ministry of Corporate Affairs (“MCA”) and SEBI. He also apprised the members of the guidelines for smooth participation in the meeting.
3. Mr. Gautam introduced the panelists present through VC:
 - o Mr. Manoj Khattar – Whole-Time Director
 - o Mr. Vivek Kapur – Independent Director (Chairman of Audit Committee, Nomination & Remuneration Committee and Stakeholders’ Relationship Committee)
 - o Mr. Raj Kumar Chawla – Chief Financial Officer
 - o Mr. Sushil Poddar – Partner, M/s. Sushil Poddar & Co., Statutory Auditor
 - o Mr. Ravi Sharma – Partner, RSM & Co., Scrutinizer of the meeting and Secretarial Auditor
4. In the absence of the Chairman, Mr. Manoj Khattar was requested to chair the meeting. He welcomed the shareholders and called the meeting to order as the requisite quorum was present.
5. Members were informed that the Statutory Registers were available for inspection in electronic mode during the AGM.
6. It was noted that the Statutory Auditor’s Report on the Financial Statements for FY 2024-25 contained no qualification, observation, or adverse remark. The Secretarial Audit Report also contained no adverse remarks.
7. The Company Secretary briefed the members on the items of business/resolutions proposed in the Notice of the AGM dated 13th August, 2025.

8. Members were informed that the Company had provided remote e-voting facility which commenced and concluded on 28th September, 2025 at 5:00 P.M.
9. The items of business as set out in the Notice were transacted at the AGM.
10. Members were invited to express queries/comments. Nine shareholders spoke on the performance and future outlook of the Company. The Chairman responded with general remarks on the performance and future plans of the Company.
11. Members who had not cast their votes through remote e-voting were provided the facility to vote electronically during the AGM through NSDL/WebEx platform.
12. The Company Secretary informed the members that the results of voting along with the consolidated Scrutinizer's Report would be declared and placed on the Company's website, the website of its Registrar & Share Transfer Agent, and would also be forwarded to the Stock Exchanges on or before 1st October, 2025.
13. The Chairman announced that the meeting would stand closed upon conclusion of e-voting. The meeting concluded at 11:55 A.M.
