Typhoon Hinnamnor heads back to Japan

TOKYO: Typhoon Hinnamnor is re-approaching Japan's southernmost prefecture of Okinawa amid unstable atmospheric conditions that are expected to lead to heavy downpours in the country's western and eastern regions, the weather agency here said on Thursday.

Tanker stranded in Suez Canal refloated

CAIRO: A large oil tanker stranded in Egypt's Suez Canal was refloated, authorities said on Thursday. "The vessel coming from Portugal ran aground in the Canal at about 7 pm on Wednesday, and tug boats released it into its navigational course five hours later," Xinhua news agency quoted George Safwat, spokesperson of the Suez Canal Authority (SCA), as saying.

2 Palestinians killed in West Bank, one by local

JERUSALEM: Two Palestinians were killed in the occupied West Bank on Thursday, the official Palestinian news agency said. The Israeli military said troops traded fire with Palestinian gunmen in the Balata refugee camp in the northern West Bank when they went to arrest a wanted Palestinian.

UN nuclear team arrives at Ukraine power plant

A team from the UN nuclear agency has arrived at the site of Europe's largest nuclear plant to inspect security conditions, the agency and Ukraine's nuclear energy operator said on Thursday, amid fighting between Russian and Ukrainian forces that prompted the shutdown of one reactor.

Enerhoatom said the International Atomic Energy Agency team, which is being led by director Rafael Grossi, arrived at the Zaporizhzhia nuclear plant that has been in the thick of recent fighting between Ukrainian and Russian forces more than six months after Russian President Vladimir Putin ordered his troops to invade Ukraine.

The company said earlier on Thursday that Russian mortar shelling had led to the shutdown of one of its reactors by its emergency protection system and had

damaged a backup power supply line used for in-house needs.

One of the plant's reactors that wasn't operating was switched to diesel generators, Enerhoatom said.

Ukraine and Russia trade blame for heavy shelling that had temporarily delayed the team's movements toward the sprawl-

ing plant on the left bank of Dnieper River in an area controlled by Russian forces.

The fighting underscored the risks faced by the team of UN inspectors that was hoping to assess the safety of the plant.

"There has been increased military activity, including this morning until very recently,"

Grossi said, adding that after being briefed by the Ukrainian military, he decided to get moving despite the inherent risks.

"But weighing the pros and cons and having come so far, we are not stopping."

Grossi, who personally negotiated with Ukrainian authorities to allow the team's passage, noted earlier that the risks were "very, very high" in the so-called grey zone between Ukrainian and Russian positions, but "we consider that we have the minimum conditions to move."

Russia's Defence Ministry said some of the Ukrainian shells landed 400 metres away from the plant's Reactor No 1. Ukrainian officials, meanwhile, accused Russian forces of shelling Enerhodar and a corridor that the IAEA team was set to go through, before it was finally able to clear checkpoints and reach the site.

Putin pays tribute to Gorbachev but won't attend his funeral

Russian President Vladimir Putin on Thursday paid tribute to Mikhail Gorbachev but will not attend the late former Soviet leader's funeral, a decision reflecting Kremlin's ambivalence about Gorbachev's legacy.

Kremlin spokesman Dmitry Peskov said that prior to departing for a working trip to Russia's westernmost Baltic exclave of Kaliningrad, Putin visited a Moscow hospital where Gorbachev's body is kept before Saturday's funeral to lay flowers at his coffin.

"Regrettably, the president's working schedule wouldn't allow him to do that on Saturday, so he decided to do that today," Peskov told reporters. Russian state television showed Putin walking to Gorbachev's open coffin and putting a bouquet of red roses next to it.

Gorbachev, who died on Tuesday, will be buried at Moscow's Novodevichy cemetery next to his wife Raisa after a farewell ceremony will be held at Pillar Hall of the House of the Unions, an iconic mansion near



the Kremlin that has served as the venue for state funerals since Soviet times. Asked if Gorbachev will be given a state funeral, Peskov said the funeral will have "elements" of state funeral, such as honorary guards, and the government will help organise it. He didn't elaborate how it will differ from an actual state funeral.

Putin's decision to pay a private visit to the hospital while staying away from Saturday's public farewell ceremony combined with uncertainty surrounding the funeral's status reflect the Kremlin's uneasiness about the legacy of Gorbachev. The late leader has been lauded in the West by putting an end to the Cold War but reviled by many at home for actions that led to the 1991 Soviet collapse and plunged millions into poverty.

Former first lady guilty a week after Najib jailed

Former Malaysian first lady Rosmah Mansor was ordered to serve 10 years in prison after being found guilty on Thursday of soliciting and receiving bribes during her husband's corruption-tainted administration, a week after he was imprisoned over the massive looting of the 1MDB state fund.

Rosmah was convicted on a charge of soliciting 187.5 million ringgit (USD 42 million) and two charges of receiving 6.5 million ringgit (USD 1.5 million) between 2016 and 2017 to help a company secure a project to provide solar energy panels to schools on Borneo island.

Taiwan shoots down 'drone' off Chinese coast

Taiwan military on Thursday said it shot down an unidentified civilian drone, which had entered its airspace over the restricted waters of Shiyu Island, just off the Chinese coast in the early hours on Thursday.

"The Jintan Defense Command of the Army stated that at 12:30 pm today, an unidentified civilian aerial camera was found to enter the airspace over the restricted waters of Shiyu Island," according to the statement released by Taiwan's Defense Ministry. "The Ministry of

Defense will continue to search, 180 km from Taiwan's main island and monitor closely to maintain but less than 10 km from China.

the security of the defence area," the statement reads.

A similar incident was reported on Tuesday where the Taiwanese military fired at a Chinese military drone after it entered the "restricted" air space over a Taiwanese-controlled island. Since mid-August, a number of civilian drones have been spotted flying over the outlying island of Kinmen, less than 10 km from China.

Taiwanese tycoon to train 3 million 'civilian warriors'

A colourful Taiwanese tycoon unveiled plans on Thursday to train more than three million "civilian warriors" to help defend the democratic island in the event of a Chinese invasion, by donating about NT\$1 billion (US\$46 million) of his own money.

Robert Tsao, 75, is one of Taiwan's most successful businessmen and founded major microchip maker United Microelectronics Corp (UMC). Born in Taichung, he was until recently a Singapore citizen, a status he renounced in August, when he announced plans to return to "die in Taiwan and stand with its people".

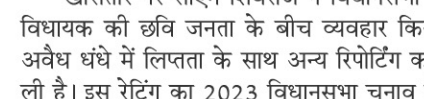
