11 from UP killed as van rams truck in Dausa

A pickup van crashed into a parked truck in Rajasthan's Dausa district in the early hours of Wednesday, killing 11 Uttar Pradesh residents, including seven children, and injuring eight others, police said.

The passengers of the pickup vehicle were returning to their village in Uttar Pradesh's Etah after visiting Khatu Shyam and Salasar Balaji temples when the accident occurred on Manoharpur highway around 4 am, Dausa SP Sagar told newsmen.

Seven children and four women died in the accident, he said.

Dausa Deputy SP Raviprakash Sharma said the deceased have been identified as Mishthi (1), Babu (3), Poorvi (6), Lakshay (6), Vaishnavi (7), Mahak (7), Saloni (9), Sheela (20), Priyanka (25), Seema (25) and Sonam (32).

Twenty people were on board the pickup vehicle when it rammed into the stationary truck on the service lane of the highway, the SP said, adding that one of the eight injured is in a critical condition. Expressing grief over the incident, President Droupadi Murmu called the loss of lives very tragic and prayed for the recovery of those injured.

"The news of the death of many people, in-



cluding women and children, in a road accident in Dausa, Rajasthan, is very tragic. I express my deep condolences to the bereaved families. I pray for the speedy recovery of those injured in this accident," the president said in a post on X in Hindi.

In view of the tragedy, the Lodhi Mahasabha has postponed the Virangana Rani Antvanti Lalodhi Shobhayatra in Etah that was scheduled

for August 16.

Rajasthan Chief Minister Bhupendra Patel Choudhary has expressed grief over the loss of lives in the accident. Sharma has instructed the concerned officials to ensure proper arrangements for the treatment of the injured.

Former Rajasthan chief minister Ashok Gehlot and other leaders also express sorrow over the incident.

Deaf-mute woman gang-raped near SP's bungalow in UP, CCTV 'eyes' were shut

BALRAMPUR

In a chilling reminder of how unsafe Uttar Pradesh can be, a deaf and mute woman was allegedly kidnaped and gang-raped just a stone's throw from the residence of Balrampur's top police and administrative officials — in an area touted to be under round-the-clock electronic watch. The twist? Several CCTV cameras installed under the state's much-hyped "Operation Trineta" were switched off when the crime unfolded.

The 21-year-old was returning from her maternal uncle's home when two bike-borne men allegedly walled her on a deserted stretch, dragged her to a nearby field, and took turns raping her. Unable to shout for help, she lay in the field until her worried family, who had started searching when she did not return for over an hour, found her in a traumatised state near a police outpost. She is recovering at the district women's hospital. Within 24 hours, police

claimed a breakthrough, arresting the accused — Ankur Verma and Harshit Pandey — after an encounter in which both suffered bullet injuries. "We traced them through available CCTV footage and other leads. They have confessed to the crime," Superintendent of Police Vikash Kumar told reporters.

But it is the political fallout that has set off a media ablaze. The All India Trinamool Congress posted the disturbing visuals from a working CCTV camera outside the SP's residence — a 14-second clip showing the victim sprinting for her life as the two men pursue her on a bike, with no one stepping in. The party blasted the Yogi Adityanath government's law-and-order claims, calling Uttar Pradesh a "graveyard for women" and accusing the BJP's "Double Engine" model of protecting criminals rather than victims.

"How dare the BJP lecture Bengal on women's safety when its own backyard is soaked in blood?" the post read, accusing the police of being "asleep or complacent."

Pack of stray dogs maul woman to death

KUSHNAGAR (UP)

A 30-year-old mentally challenged woman was mauled to death by a pack of stray dogs in Uttar Pradesh's Kushnagar district, police said.

The incident took place on Tuesday night in Arjun Dumri village under Hata police station limits.

Hata SHO Rameshwar Chaudhary said they received a call around 7 pm that the body of Madhuri was lying in a paddy field near the village panchayat building and was being attacked by stray dogs. Police personnel rushed to the scene, chased the dogs away with sticks, and took the body into custody. The SHO said the woman was

mentally challenged and had likely gone behind the panchayat building for some reason on Tuesday, where she died.

The dogs were later found mauling the body.

According to the villagers, the woman often roamed around the village and had gone missing on Monday. Her family searched for her but could not trace her.

On Tuesday, her body was found in the paddy field with parts of it eaten away by dogs, they said.

The villagers have alleged that stray dogs have been a menace in the area and cited previous incidents, including the killing of a cow a year ago and a goat eight months ago.

Statehood plea: SC to hear J&K case today

The Supreme Court would on Thursday hear a plea for the restoration of statehood to Jammu and Kashmir.

A bench of Chief Justice of India B R Gavai and Justice K Vinod Chandran is likely to hear the matter, according to the court's list.

On December 11, 2023, the Supreme Court unanimously upheld the revocation of Article 370, even as it ordered that assembly elections be held in Jammu and Kashmir by September 2024 and its statehood be restored "at the earliest".

Last year, a plea was filed in the

top court seeking directions to the Centre for the restoration of statehood to Jammu and Kashmir within two months.

The application was filed by Za-

hoor Ahmad Bhat, an academician, and Khursaid Ahmad Malik, a socio-political activist.

"It is submitted that the delay in the restoration of statehood would cause serious reduction of democratically elected government in Jammu and Kashmir, causing a grave violation of the idea of federalism which forms part of the basic structure of the Constitution of India," the application said.

The assembly elections and the Lok Sabha polls were conducted peacefully in Jammu and Kashmir

without any incident of violence, disturbance or any security concerns being reported, it said.

"Therefore, there is no impediment of security concerns, violence or any other disturbances which would hinder or prevent the grant/restoration of the status of statehood to Jammu and Kashmir as had been assumed by the Union of India in the present proceedings," the plea said.

The non-restoration of the status of statehood of Jammu and Kashmir, the plea said, would result in a lesser form of elected democratic government to the state, particularly given legislative assembly results were declared on October 8, 2024.

Killed 2,800 dogs, can go to jail if needed: Shocker from Kar leader

A leader from HD Kumaraswamy's Janata Dal Secular has admitted to killing 2,800 dogs to ensure "the safety of children", MLC SL Bhogojada said in the Legislative Council today. "But you see the suffering of young children. You read about this daily in the papers and TV. It is happening every day," he said.

Then he recounted what happened "once upon a time" when he checked a dog's body in Chikmagalur. "We had mixed something with meat and fed about 2,800 dogs and buried them under coconut trees... let's go to jail also if needed for the safety of our kids," he said.
