## Red alert for...

A Monsoon trough is passing through Gwalior and Sidhi to North-east Bay of Bengal indicating monsoon to be active in state. However, low pressure area over east Madhya Pradesh has weakened. A cyclonic circulation is persisting over this area and is expected to move to West or Northwest direction towards Northern parts of MP. However, a few areas of the state have recorded above normal rainfall. While Guna has recorded 122% above normal rain, Sheopur has received 131% more than normal downpour. Against normal of 490.4mm rain, Sheopur has till date recorded 1,133 mm rain. Similarly, Guna has received 1347.8mm of rain against normal of 608.4 mm. Indore has reported 27% deficient rain so far after receiving 406.8 mm of rain against normal of 558.1mm. Bhopal too has reported below normal rain as the city has received 644mm rain against normal of 670mm. Singrauli has recorded 12cm rain while Seoni Malwa recorded 11cm and Agar 9cm of rain in last 24 hours. Similarly, Karanjia and Mahidpur recorded 7cm rain each while Shajapur, Anuppur and Simaria recorded 6cm of rain each. In the last 24 hours, light to moderate rain with few heavy spells occurred over Madhya Pradesh. During the next 24 hours, light to moderate rain with a few heavy spells are possible over Madhya Pradesh.

## Scindia speaks highly...

Historians accuse the Scindia dynasty, the ancestors of BJP leader Scindia, of joining hands with the British to scuttle what was described as the "sepoy mutiny" of 1857 and betray Rani Laxmibai. The Scindia dynasty ruled the erstwhile princely state of Gwalior.

## Done with being...

In Khost province, Taliban authorities instituted a 24-hour curfew on Thursday after violently breaking up another protest, according to information obtained by journalists monitoring from abroad. The militants did not immediately acknowledge the demonstration or the curfew. Protesters also took the streets in Kunar province, according to witnesses and social media videos that lined up with reporting by The Associated Press. The demonstrations, which come as Afghans mark the Independence Day holiday that commemorates the 1919 treaty that ended British rule, were a remarkable show of defiance after the insurgents violently dispersed a protest Wednesday. At that rally, in the eastern city of Jalalabad, demonstrators lowered the Taliban's flag and replace it with Afghanistan's tricolor. At least one person was killed.

## Atal Progress-Way included...

PWD minister Gopal Bhargava expressed his gratitude to the Union Minister for Road, Transport and Highways Nitin Gadkari on the approval and said, "Tenders for this project would now be floated very soon." He gave credit for the project to the chief minister Shivraj Singh Chouhan for his continuous interest and review meetings.

## Guj's 'Love Jihad'...

On Thursday, Chief Justice Nath said, "We are of the opinion that pending further hearing, rigors of section 3, 4, 4a to 4c, 5, 6, and 6a shall not operate merely because the marriage is solemnised by a person of one religion with another religion without force, allurement or fraudulent means and such marriages cannot be termed as marriage for the purpose of unlawful conversion." "This interim order is to protect the parties which solemnised interfaith marriages from unnecessary harassment," he said. The stay on these sections effectively means that an FIR under this law cannot be lodged merely on the basis of his or her interfaith marriage. When state Advocate General Kamal Trivedi sought a clarification, saying what if a marriage results in forceful conversion, Chief Justice Nath said,

## HC seeks govt...

However, only seven policemen were given benefits of government schemes. The petitioner claimed that the state government, considering policemen as frontline workers, had announced Rs 50 lakh to the dependents of policemen, who died fighting coronavirus. The petitioner informed the bench that 40 police died in the first corona wave and over 112 died in the second wave. However, the government record stated that only seven police personnel were given benefits under 'COVID-19 Youdhya Schemes'.

## HC orders CBI...

It said that the working of the SIT will be overseen by a retired judge of the Supreme Court for which a separate order will be passed after obtaining his/her consent. In its ruling, the bench said crimes such as murder and rape "deserve to be investigated by an independent agency which in the circumstances can only be the Central Bureau of Investigation". The bench said the state failed to register FIRs even in some cases of alleged murder.

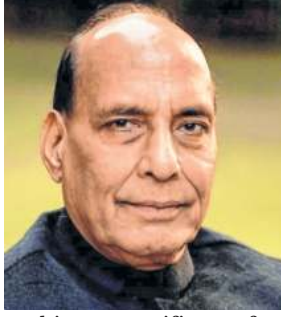

## Sheopur youths dared...

Many residents went to the rooftops to protect their families from the deluge. The carcasses of dogs, cats and cows were floating around Ashish and his team members. They had no time to see all this. As a few places were still accessible they reached there and shifted some people to a school behind Jayashri Palace. Kasrade said the deluge had wreaked havoc on 60% of 150,000 inhabitants in the city. Nearly 100 flood-hit crammed into the school building, which was too small to house more, another resident of the area Baiju Barange added. He, too, took shelter in the school building. Many residents then opened their doors to the flood-affected, Ashish said. There was a problem with food. Many residents could not cook, as they had to scuttle for cover. There was no dearth of people assisting the rescuers. Baiju said food packets were ready by 5pm. The next hurdle was to reach those houses to hand over the food packets to those who were trapped there. Most of the houses were under 15-foot water, Baiju added. There was no light, besides, The snakes and other poisonous creatures were lurking around. Except for the sounds of rainfall and the croaking of toads, nothing was audible. On the other hand, the cataracts of water, as high as the first floor, sluiced along, he said. The rescuers did not give up. They yoked a few tubes to a rope. Ashish, then, set out to distribute those food packets with the help of those tubes, Baiju said. Ashish reached the balconies of several houses.

# National security challenges becoming complex: Rajnath

India's national security challenges are becoming "complex" in view of rapidly changing geopolitical scenario globally and there is a need to create a capable and self-reliant defense industry besides a strong and modern military, Defence Minister Rajnath Singh said on Thursday.

Singh's comments came amid growing concerns in India and elsewhere over the Taliban sweeping across Afghanistan this month, seizing control of almost all key Afghan towns and cities including Kabul following the withdrawal of the US forces.

"Today, the security scenario in the whole world is changing very fast. Because of this, the challenges to our national security are increasing and becoming complex. There are constant changes in the global geopolitical situation," Singh said, without

modern and well-equipped forces, but also develop our defence industry, which is equally strong, capable, and most importantly, completely 'self-reliant'," the defence minister said. "There is neither a shortage of talent in our country, nor is there a lack of demand for talents. But in the absence of a common platform, the two could not match. 'IDEX' platform has been successful to a large extent in bridging this gap," he said. The DISC 5.0 focuses in areas such as artificial intelligence, non-lethal devices, 5G network, under-water domain awareness, Swarm drones and data capturing among others. The defence minister called upon the private sector to contribute in strengthening the defence manufacturing sector. "While assuring all possible cooperation from the government, I call upon the private sector to come forward and contribute in building a strong and self-reliant defence sector," he said.

He was speaking after launching the 'Defence India Startup Challenge 5.0 (DISC 5.0)', an initiative under the Innovations for Defence Excellence (IDEX) that acts as an umbrella organisation to promote technology development for the defence sector.

Singh said considering the fast-changing security challenges, India must focus on having a strong, capable, and 'self-reliant' defence industry to cater to the needs of the armed forces. "It is necessary that we not only create strong,

## SC Collegium approves 14 names for elevation as judges

The Supreme Court Collegium has recommended the appointment of 14 judges to the three High Courts of Telangana, Karnataka and Calcutta, along with the names of nine Supreme Court judges. This was decided during a meeting on August 17.

The six judicial officers who have been elevated as

judges of the Telangana High Court are P Sree Sudha, C Sumalatha, G Radha Rani, M Laxman, N Tukaramji and A Venkateswara Reddy. Besides, the Collegiums also approved the proposal for the elevation of Income Tax Appellate Tribunal judicial member P Madhavi Dev as judge of the Telangana high court.

Meanwhile, six additional judges of the Karnataka

High Court were elevated to permanent judges. These judges are Justices Naranahalli Srinivasan Sanjay Gowda, Jyoti Mulimani, Nataraj Rangaswamy, Hemant Chandgoudar, Pradeep Singh Yerur and Maheshan Nagrasanna.

Also, additional judge Kausik Chanda of the Calcutta High Court has been elevated as permanent judge.

## Soldier martyred, terrorist killed in Rajouri

A Junior Commissioned Officer (JCO) of the army died in a fierce gun fight with militants in Jammu and Kashmir's Rajouri district on Thursday in which a terrorist was also killed, the army said. Security forces had launched a search operation in Thanamandi belt following inputs about the presence of terrorists there, a police officer said. The search operation turned into an encounter after the terrorists opened fire on the forces, he said. "A JCO of the Rashtriya Rifles suffered bullet injuries in the encounter.

## Investigation in Sheena Bora murder case closed

MUMBAI

The CBI has informed the special court in Mumbai that it will not carry out further investigation in the Sheena Bora murder case earlier this week.

In a written intimation submitted before the court, the CBI said it will not be investigating the

case further. The same has been noted by the court in its Roznama (Daily order) on Tuesday. CBI was investigating the Sheena Bora case since 2015, after taking over the case from Mumbai Police.

According to the case registered by Mumbai Police, Sheena Bora was kid-

napped and murdered by strangulation in April 2012. Four persons were made accused in this case, including Indrani Mukerjea and her husband Peter Mukerjea. Later, the case was transferred to CBI, which had filed multiple charge sheets in this case against four accused.

## CG MLA abuses Deputy Collector, audio goes viral

An audio clip in social media was claimed to be of controversial MLA Balrampur, Brihaspati Singh in which he was heard verbally abusing the deputy collector for the action taken by him in a case.

Singh was heard abusing Deputy Collector Prafull Rajak over phone for awarding Dakko pond fish farming patna to the other party who won the case. The MLA also used demeaning words against the deputy collector and threatened to beat him with shoes. Even though the officer requested him not to use foul language, the MLA did not stop there and finally the officer disconnected the call.

The officer also complained the matter to his senior officers and demanded action against the MLA.

The officer said, he was feeling hurt from the unexpected abusive behaviour of the MLA. He received the phone call while he was visiting a doctor.

## As Tejashwi vs Tej Pratap flares up, Lalu picks a side

**PATNA:** The fight between Tejashwi Yadav and his brother Tej Pratap escalated in Bihar's Rashtriya Janata Dal (RJD) after state party president Jagdanand Singh sacked youth wing state head, Akash Yadav, creating yet another crisis in the state unit.



Akash Yadav, Tej Pratap's protege, was collateral damage in the sibling rivalry. Sources say Tejashwi Yadav, Lalu Yadav's younger son and political heir, had his father's tacit approval.

Before sacking Akash Yadav, Tejashwi also persuaded a Tej Pratap adversary, Jagdanand Singh to come out of his sulk. An upset Jagdanand Singh, the chief of RJD's Bihar unit, had stopped going to office after Tej Pratap accused him of running the party "Hitler-style".

Lalu Yadav, who has resumed his political activities since his release from jail earlier this year, has been "monitoring" the shenanigans and cleared Tejashwi's moves knowing full well that his older son Tej Pratap would be furious. The RJD veteran believes that if Tej Pratap is not reined in now, he will continue to needle Tejashwi and that is unacceptable to him. RJD sources believe Lalu Yadav has decided that enough is enough when it comes to Tej Pratap, who has been a constant source of embarrassment for the party with his controversial statements, his penchant for posing in costumes, and his rocky marriage.

After meeting with Tejashwi on Wednesday, Jagdanand Singh said he would continue in the post only because of Lalu Yadav. Mr Singh declared that anyone was free to say anything about him but no indiscipline would be tolerated. It was an indirect reference to Tej Pratap's tweet, which implied that the manner of Akash Yadav's removal violated the party's constitution.

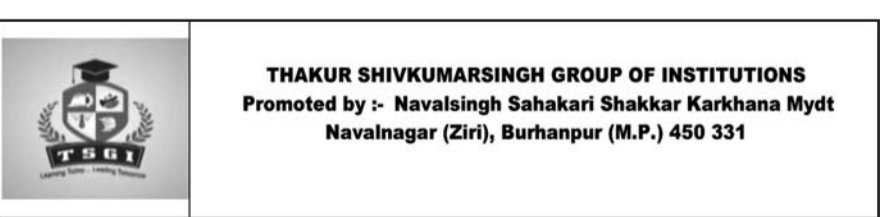
