FROM MILK TO LIQUOR, KERALA DRINKS IN THE ONAM SPIRIT

IANSS
THIRUVANANTHAPURAM

If Onam is about celebrations on nature's munificence, Kerala appears to have taken the instruction rather literally, with milk flowing in abundance and liquor not far behind.

Milma recorded a 5.61 per cent increase in milk sales, selling 1.46 crore litres between August 20 and Uthradam (the first Onam) on August 25. Curds did even better, registering a 9.68 per cent jump with sales crossing 18 lakh kg during the same period.



And then there was the other side of the festive table. Liquor sales through BEVCO and Consumerfed surged to Rs 771.29 crore in the eight days leading up to Uthradam, compared with Rs 694.96 crore during the corresponding period last year, an increase of nearly 11 per cent.

Uthradam itself proved to be a particularly busy day for Kerala's liquor outlets. Sales touched Rs 126.31 crore, with Consumerfed outlets alone accounting for around Rs 20 crore.

Major outlets of both networks witnessed heavy crowds as Malayalis stocked up for the festival.

So, while the traditional Onam kitchen was busy preparing payasam, avial, and an elaborate sadya, the state's retail counters were keeping pace in their own very different ways.

Milk, too, had its own festive rush. The Thiruvananthapuram regional union recorded a 5.86 per cent rise in milk sales and a 7.94 per cent increase in curd sales.

The Ernakulam union reported growth of 4.2 per cent in milk and 16.44 per cent in curd, while the Malabar region recorded increases of 6.03 per cent and 8.7 per cent respectively. Ghee, an essential ingredient in the Onam culinary universe, also moved briskly.

The Thiruvananthapuram union sold 297.85 tonnes between August 1 and 25, while the Ernakulam and Malabar unions recorded sales of 172.58 tonnes and 358.35 tonnes, respectively.

HC refuses interim relief to Mamata faction on 4 frozen TMC bank accounts

The Calcutta High Court on Thursday refused any interim relief to the Mamata Banerjee-led Trinamool Congress faction on the freezing of four party bank accounts in a branch of a public sector bank.

The "original but minority" faction of the Trinamool Congress, led by the former West Bengal Chief Minister, Mamata Banerjee and her nephew, Abhishek Banerjee, approached the High Court to seek lifting of the debit restrictions on four bank accounts of the party held at Harish Mukherjee Road Branch of the bank.

The bank authorities had imposed the debit restrictions on these four bank accounts following the instructions from the West



Bengal Police.

In the plea, the Mamata Banerjee-led faction argued that lifting of debit restrictions was necessary to meet the daily expenses of the party, especially paying the salaries to 215 party whole-timers.

In the plea, this faction of the former ruling party in the state also pleaded for a stay on the case registered at the Cybercrime Police Station under the Bidhannagar City Police in North 24 Parganas district, in relation to which the state police instructed

the debit restrictions.

The matter came up for hearing on Thursday before the bench of Justice Saugata Bhattacharya, and he refused to give any relief in the matter.

Instead, he directed the state government to file an affidavit in the matter, to be followed by a counter-affidavit by the Mamata Banerjee-led faction.

He also observed that the matter will be heard only after the affidavit and the counter-affidavit are filed, and only then will the court take a decision in the matter.

Justice Bhattacharya also observed that although in the past, the same bench allowed a partial and conditional de-freezing of four bank accounts of the Trinamool with a private sector bank, in this case, the court would not give any instruction right at this moment.

Ruckus in Hry Assembly as Cong MLAs allege manhandling at Vidhan Sabha gate

Ruckus ensued in Haryana Assembly for nearly two hours on the first day of the Monsoon Session on Thursday, leading to adjournments twice, as Congress MLAs questioned why their peaceful protest was stopped by security personnel at the Vidhan Sabha gate and they were manhandled.

The Congress legislators asked whether they did not have the right to carry out a democratic protest, while Speaker Harvinder Kalyan maintained that it was everybody's responsibility to follow rules and regulations.

The disruptions led to the Speaker suspending eight Congress MLAs for the remainder of the day's proceedings.

KMC removes billboard from Abhishek's office after scuffle

Officials of the Kolkata Municipal Corporation (KMC), with the help of Kolkata Police, on Thursday finally removed the giant billboard carrying the name of "All India Trinamool Congress" and the party's logo from the roof of the party office of Trinamool Congress general secretary and Diamond Harbour Lok Sabha member Abhishek Banerjee.

The KMC and police officials successfully removed it on the second attempt. Initially, when the joint team reached the office in the afternoon, Abhishek and his associates challenged the KMC notice's legal validity. Abhishek, also the nephew

of former West Bengal Chief Minister Mamata Banerjee, argued that the notice was invalid because the billboard picture was not attached to the order copy. The KMC officials returned to get a revised order.

They returned soon with the revised order, and this time the police cordoned off the entire area. Thereafter, KMC officials, accompanied by the cops, climbed the stairs to reach the roof of the building to remove the billboard.

Abhishek's associates, including Trinamool Rajya Sabha member Derek O'Brien, tried to block their movement by forming human walls on the staircase. Those blocking the path included some Trinamool women activists.
